The A465 Trunk Road (Aberdulais Interchange to Neath Interchange, Neath Port Talbot) (Temporary Traffic Prohibitions & Restrictions)
Order 2020

Made 9 October 2020

Coming into force 12 October 2020

The Welsh Ministers, as traffic authority for the A465 trunk road, are satisfied that traffic on specified lengths of the trunk road should be prohibited and/or restricted because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. The title of this Order is the A465 Trunk Road (Aberdulais Interchange to Neath Interchange, Neath Port Talbot) (Temporary Traffic Prohibitions & Restrictions) Order 2020 and it comes into force on 12 October 2020.

2. In this Order—

"exempted vehicle" ("cerbyd esempt") means:

(a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(2); and

- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds;

"special forces" ("lluoedd arbennig") means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

"the trunk road" ("y gefnffordd") means the A465 Neath to Abergavenny trunk road;

"works period" ("cyfnod y gwaith") means that period commencing at 20:00 hours on 12 October 2020 and ending when the temporary traffic signs are permanently removed.

Prohibitions and Restrictions

- **3.** No person may, during the works period, drive any vehicle on the lengths of the trunk road specified in Schedule 1 to this Order.
- **4.** No person may, during the works period, drive any vehicle with a width of or exceeding 2.9 metres on the lengths of the trunk road specified in Schedule 1 to this Order.
- **5.** No person may, during the works period, ride any pedal cycle on the lengths of the trunk road specified in Schedule 2 to this Order.
- **6.** No person may, during the works period, drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of the trunk road specified in Schedule 3 to this Order.
- **7.** No person may, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of the trunk road specified in Schedule 3 to this Order.

Application

- **8.**—(1) The prohibitions and restrictions in articles 3, 4, 5, 6 and 7 apply only during such times and to such extent as indicated by traffic signs.
- (2) No speed limits imposed by this Order apply to an exempted vehicle.

Suspension

9. Any statutory provisions restricting the speed of vehicles on the lengths of the trunk road specified in Schedule 3 to this Order are suspended during such times as the restrictions specified in articles 6 and 7 are in operation.

Duration of this Order

10. The maximum duration of this Order is 18 months.

SCHEDULE 1 Temporary Prohibition of Vehicles

The length of the eastbound carriageway of the trunk road at Aberdulais Interchange that extends from the nosing of the eastbound exit slip road to the nosing of the eastbound entry slip road.

The length of the westbound carriageway of the trunk road at Aberdulais Interchange that extends from the nosing of the westbound exit slip road to the nosing of the westbound entry slip road.

The lengths of the eastbound and westbound exit and entry slip roads at Aberdulais Interchange.

The length of the eastbound carriageway of the trunk road that extends from its junction with the circulatory carriageway at Neath Interchange to the nosing of the eastbound entry slip road at Aberdulais Interchange.

The length of the westbound carriageway of the trunk road that extends from the nosing of the westbound exit slip road at Aberdulais Interchange to its junction with the circulatory carriageway at Neath Interchange.

SCHEDULE 2 Temporary Prohibition of Cyclists

The length of the eastbound carriageway of the trunk road at Aberdulais Interchange that extends from the nosing of the eastbound exit slip road to the nosing of the eastbound entry slip road.

The length of the westbound carriageway of the trunk road at Aberdulais Interchange that extends from the nosing of the westbound exit slip road to the nosing of the westbound entry slip road.

The lengths of the eastbound and westbound exit and entry slip roads at Aberdulais Interchange.

The length of the eastbound carriageway of the trunk road that extends from the nosing of the eastbound exit slip road at Neath Interchange to its junction with the main circulatory carriageway of Resolven Roundabout, including the eastbound entry slip roads at Neath and Aberdulais Interchanges.

The length of the westbound carriageway of the trunk road that extends from its junction with the circulatory carriageway of Resolven Roundabout to the nosing of the westbound entry slip road at Neath Interchange including the westbound entry slip road at Aberdulais Interchange.

SCHEDULE 3 Temporary 30 mph or 50 mph Speed Limits

The length of the eastbound carriageway of the trunk road that extends from a point 1.5 kilometres west of the nosing of the eastbound exit slip at Aberdulais Interchange to a point 1.5 kilometres east of the nosing of the eastbound entry slip road at that interchange.

The length of the westbound carriageway of the trunk road that extends from a point 1.5 kilometres east of the nosing of the westbound exit slip road at Aberdulais Interchange to a point 1.5 kilometres west of the nosing of the westbound entry slip road at that interchange.
