ROAD TRAFFIC, WALES

The A470 Trunk Road (Northbound Lane at Black Cat Roundabout, Conwy) (Temporary Traffic Prohibitions) Order 2020

Made 14 October 2020

Coming into force 16 October 2020

The Welsh Ministers, as traffic authority for the A470 Trunk Road, are satisfied that traffic on a specified length of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. The title of this Order is the A470 Trunk Road (Northbound Lane at Black Cat Roundabout, Conwy) (Temporary Traffic Prohibitions) Order 2020 and it comes into force on 16 October 2020.

2. In this Order—

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services, public service buses or in connection with the works giving rise to this Order;

"the trunk road" ("y gefnffordd") means the A470 Maentwrog to East of Conwy Trunk Road that forms the northbound lane leading to Conwy

road and the A55 Glan Conwy Roundabout, Conwy.

"works period" ("cyfnod y gwaith") means the period commencing at 07:00 on 16 October 2020 and ending when the temporary traffic signs are permanently removed.

Prohibitions

- **3.**No person may, during the works period, permit any vehicle, other than an exempted vehicle, to make a right hand turn from A547 on the length of the trunk road specified in article 2 to this Order.
- **4.**No person may, during the works period, permit any vehicle, other than an exempted vehicle to travel northbound on from B5381 on the length of the trunk road specified in article 2 to this Order.
- **5.** No person may, during the works period, ride any pedal cycle on the length of the trunk road.
- **6.** No pedestrian may, during the works period, proceed on the length of the trunk road.

Application

7.The prohibitions in articles 3, 4, 5, and 6 apply only during such times and to such extent as indicated by traffic signs.

Duration of this Order

8. The maximum duration of this Order is 18 months.
