The A470 & A458 Trunk Roads
(Moat Lane Level Crossing,
Caersws and Buttington Level
Crossing, Buttington, Powys)
(Temporary Prohibition of Vehicles)
Order 2020

Made 17 March 2020

Coming into force 20 March 2020

The Welsh Ministers, as traffic authority for the A470 trunk road and the relevant length of the A458 trunk road, are satisfied that traffic on specified lengths of the trunk roads should be prohibited because of works proposed on or near the roads.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. The title of this Order is the A470 & A458 Trunk Roads (Moat Lane Level Crossing, Caersws and Buttington Level Crossing, Buttington, Powys) (Temporary Prohibition of Vehicles) Order 2020 and it comes into force on 20 March 2020.

2. In this Order—

“the trunk roads” (“*y cefnffyrdd*”) means the A470 Newtown to Aberystwyth Trunk Road and the A458 Shrewsbury to Dolgellau Trunk Road;

By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c.32), these powers are now exercisable by the Welsh Ministers in relation to Wales.

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing on 20 March 2020 and ending when the temporary traffic signs for each period of works are removed.

Prohibition

3. No person may, during the works period, drive any vehicle on the lengths of the trunk roads specified in the Schedule to this Order.

Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

Duration of this Order

5. The maximum duration of this Order is 18 months.

SCHEDULE

The length of the A470 trunk road at Caersws, Powys that extends from a point 20 metres north of Moat Lane level crossing to a point 20 metres south of the level crossing.

The length of the A458 trunk road at Buttington, Powys that extends from a point 20 metres east of Buttington level crossing to a point 20 metres west of the level crossing.
