# ROAD TRAFFIC, WALES

The A5 Trunk Road (Pentrefoelas, Conwy) and the A470 Trunk Road (Llanrwst, Conwy) (Temporary Prohibition of Vehicles, Cyclists and Pedestrians) Order 2021

Made 7 September 2021

Coming into force 8 September 2021

The Welsh Ministers, as traffic authority for the A5 and A470 trunk roads, are satisfied that traffic on specified lengths of the trunk roads should be prohibited by reason of a relevant event, namely the Tour of Britain Stage 4, being held on or near the roads.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 16A of the Road Traffic Regulation Act 1984(1), make this Order.

## Title and commencement

**1.** The title of this Order is the A5 Trunk Road (Pentrefoelas, Conwy) and the A470 Trunk Road (Llanrwst, Conwy) (Temporary Prohibition of Vehicles, Cyclists and Pedestrians) Order 2021 and this Order comes into force on 8 September 2021.

### Interpretation

### 2. In this Order—

"closure period" ("y cyfnod cau") means that period commencing at 00:00 hours on 8 September

2021 and ending when the temporary traffic signs are permanently removed:

"exempted vehicle" ("cerbyd esempt") means:

- (i) any public service vehicle;
- (ii) any vehicle being used for police purposes;
- (iii) any vehicle being used for the purpose of fire or ambulance services;
- (iv) any vehicle being used in connection with works to the road or lighting or traffic signs or emergency works to any sewer or to any main or apparatus for the supply of gas, water or electricity, or telecommunications in, or in any land adjacent to, a length of road concerned;
- (v) any vehicle used by an authorised event official in support of and for safety reasons of the relevant event.

"the trunk roads" ("y cefnffyrdd") means the A5 Maentwrog to East of Conwy trunk road and the A470 London to Holyhead trunk road as follows:

- (i) the length of the A5 trunk road in the County of Conwy that extends from the centre-point of its junction with the B4407 to the centre-point of its junction with the B5113, at Pentrefoelas;
- (ii) the length of the A470 trunk road in the County of Conwy that extends from the centre-point of its junction with the B5427 (Nebo Road) to the centre-point of its junction with the B5106 (Pont Fawr) at Llanrwst.

#### **Prohibitions**

- **3.** No person may, during the closure period, drive any vehicle, other than an exempted vehicle on the lengths of the trunk roads.
- **4.** No person may, during the closure period, ride any pedal cycle on the lengths of the trunk roads.
- **5.** No pedestrian may, during the closure period, proceed on the lengths of the trunk roads.

## **Application**

**6.** The prohibitions in article 3, 4 and 5 applies only during such times and to such extent as indicated by traffic signs.

# **Duration of this Order**

**7.** The maximum duration of this Order is 1 day.
