**ROAD TRAFFIC, WALES**

**The A465 Trunk Road  
(Llanvihangel Crucorney to Pandy,  
Monmouthshire) (40 mph & 50  
mph Speed Limits) Order 2021**

*Made* 12 May 2021

*Coming into force* 17 May 2021

The Welsh Ministers, as traffic authority for the A465 trunk road, and in exercise of the powers conferred upon them by sections 84(1)(a), (2) and 124(1)(d) of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984(1), make this Order.

The Welsh Ministers have consulted with the Chief Officer of Gwent Police and given public notice of their intention to make this Order in accordance with regulations 5(1) and 6(1) of the Secretary of State's Traffic Orders (Procedure) (England and Wales) Regulations 1990(2).

**Title and commencement**

1. The title of this Order is the A465 Trunk Road (Llanvihangel Crucorney to Pandy, Monmouthshire) (40 mph & 50 mph Speed Limits) Order 2021 and this Order comes into force on 17 May 2021.

**Interpretation**

2. In this Order—

“exempted vehicle” (“*cerbyd esempt*”) means:

- (a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984<sup>(1)</sup>;
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
  - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
  - (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (*“lluoedd arbennig”*) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (*“y gefnffordd”*) means the A465 Newport to Shrewsbury trunk road.

### **Restrictions**

**3.** No person may drive any motor vehicle, other than an exempted vehicle, at a speed exceeding 40 miles per hour on the length of the trunk road specified in Schedule 1 to this Order.

**4.** No person may drive any motor vehicle, other than an exempted vehicle, at a speed exceeding 50 miles per hour on the lengths of the trunk road specified in Schedule 2 to this Order.

### **Revocation**

**5.** The A465 Trunk Road (Llanvihangel-Crucorney, Werngifford and Pandy, Monmouthshire) (40 mph & 50 mph Speed Limits) Order 2003<sup>(2)</sup> is revoked.

**SCHEDULE 1**  
**40 mph speed limit**

The length of the trunk road that extends from a point 330 metres south of the centre of its junction with the unclassified road at Werngifford to a point 430 metres north of the centre of that junction.

**SCHEDULE 2**  
**50 mph speed limit**

The length of the trunk road that extends from a point 375 metres south of the centre of its junction with Old Hereford Road, Llanvihangel Crucorney to a point 330 metres south of the centre of its junction with the unclassified road at Werngifford.

The length of the trunk road that extends from a point 430 metres north of the centre of its junction with the unclassified road at Werngifford to a point 46 metres north of the centre of its junction with the R46 county road to Penishaplwydd.
