This Order will trunk and de-trunk sections of the A487 trunk road at Chimneys Link, Fishguard, following the construction by Pembrokeshire County Council of the new Ffordd-yr-Efail link road

The Fishguard to Bangor Trunk Road (A487) (Chimneys Link Trunking and De-Trunking, Pembrokeshire) Order 2022

Made 12 July 2022

Coming into force 22 July 2022

1. The Welsh Ministers, in exercise of powers conferred by sections 10 and 12 of the Highways Act 1980(1), make this Order.

Title, Commencement and Interpretation

The title of this order is the Fishguard to Bangor Trunk Road (A487) (Chimneys Link Trunking and De-Trunking, Pembrokeshire) Order 2022 and it comes into force on 22 July 2022.

2. In this Order:-

All measurements of distance are measured along the route of the relevant highway;

(i) "classified road" ("ffordd ddosbarthiadol") as a classification for a highway, means that the highway is not a principal road for the purpose of enactments and instruments which refer to highways classified as principal roads and is also classified for the purpose of every other enactment and instrument which refers to highways classified by the Welsh Ministers and which does not refer

- specifically to their classification as principal roads;
- (ii) "the deposited plan" ("y plan a adneuwyd") means the plan numbered HA10/2 WG20 and marked "The Fishguard to Bangor Trunk Road (A487) (Chimneys Link Trunking and DeTrunking, Pembrokeshire) Order 2022", signed on behalf of the Welsh Ministers and deposited (ref qA1452133) at the Welsh Government, Information and Records Management Unit, Cathays Park, Cardiff;
- (iii) "the trunk road" ("y gefnffordd") means the Fishguard to Bangor Trunk Road (A487).

Highways to become trunk roads

- **3.** The highways described in Schedule 1 to this Order and which are shown on the deposited plan shall become trunk roads as from the date when this Order comes into force.
- **4.** The centre lines of the new trunk roads are indicated by a heavy black line on the deposited plan.

Lengths of trunk road ceasing to be trunk roads

5. The length of the trunk road described in Schedule 2 to this Order, and shown by broad striped hatching on the deposited plan, shall cease to be trunk road and shall become a classified road as from the date on which the Welsh Ministers provide notification of this to Pembrokeshire County Council, who will become the highway authority for that length of road.

SCHEDULE 1

ROUTES OF THE NEW TRUNK ROADS

A route of approximately 231 metres in length at Fishguard in the County of Pembrokeshire commencing at the centre point of the junction between the A40 High Street in a north eastern direction on A487 length of highway known as Ffordd Yr Efail to the centre point of its junction with the A487 West Street, Fishguard, shown as a heavy black line on the deposited plan.

SCHEDULE 2

LENGTH OF TRUNK ROAD CEASING TO BE A TRUNK ROAD

A length of approximately 1066 metres of the existing A487 trunk road at Chimneys Link, Fishguard in the County of Pembrokeshire, commencing at a point 8metres north west of the centre point of the junction between A487 West Street and A487 Ffordd-yr-Efail to the centre point of A487 Windyhall Roundabout eastern arm shown by broad striped hatching on the deposited plan.
