# ROAD TRAFFIC, WALES

The A483 Trunk Road (Crossgates, Powys) (Temporary Prohibition of Traffic) Order 2023

Made 18 September 2023

Coming into force 25 September 2023

The Welsh Ministers, as traffic authority for the relevant length of the A483 trunk road, are satisfied that traffic on a specified length of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

#### Title and commencement

**1.** The title of this Order is the A483 Trunk Road (Crossgates, Powys) (Temporary Prohibition of Traffic) Order 2023 and this Order comes into force on 25 September 2023.

#### Interpretation

### 2. In this Order—

"the trunk road" ("y gefnffordd") means the length of the A483 Swansea to Manchester trunk road that extends from a point 75 metres north of the centre-point of its junction with the access road leading to St Padarn's Church to its roundabout junction with the A44 at Crossgates, Powys;

"works period" ("cyfnod y gwaith") means intermittent periods commencing at 18:00 hours on 25 September 2023 and ending when the temporary traffic signs for each period of works are permanently removed.

#### **Prohibitions**

- **3.** No person may, during the works period, drive any vehicle on the length of the trunk road specified in article 2 of this Order.
- **4.** No person may, during the works period, ride any pedal cycle on the length of the trunk road specified in article 2 of this Order.
- **5.** No equestrian may, during the works period, proceed on the length of the trunk road specified in article 2 of this Order.
- **6.** No person may, during the works period, permit any livestock to proceed on the length of the trunk road specified in article 2 of this Order.

## **Application**

**7.** The prohibitions in articles 3, 4, 5 and 6 apply only during such times and to such extent as indicated by traffic signs.

### **Duration of this Order**

**8.** The maximum duration of this Order is 18 months.
