- 1. This is an application for a determination of costs under Section 33 of the Leasehold Reform, Housing and Urban Development Act 1993.
- 2. On 18 October 2007 Directions were issued by the Tribunal to the effect that unless the parties objected the question of costs would be dealt with by way of a paper determination on receipt of written representations.
- 3. On 30 November 2007 the respondent's statement of costs together with the applicant's reply were received.
- 4. On 24 January 2008 the Tribunal considered the two statements. The Respondents were seeking costs totaling £3,346 + VAT, made up of 9 hours and 40 minutes of partner time @ £220 per hour and 6 hours and 48 minutes of assistant solicitor time @ £175 per hour. The applicants considered £1388. 50p + VAT to be reasonable made up of 204 minutes of partner time and 210 minutes of assistant solicitor time. They did not contest either hourly rate.
- 5. The main contention between the parties was the time spent on a lease extension for the non participating tenant who was also the freeholder.
- 6. The Tribunal was assisted by the fact that the applicants had, helpfully, appended their comments retaining the same numbering as the respondents. The Tribunal, therefore, provide their determination adopting the same format.
