Sentencing by the Superior Number of the Royal Court, to which the accused was remanded by the Inferior Number on 3rd February, 1995, following guilty pleas to:

2 counts of

being knowingly concerned in the fraudulent evasion of the prohibition on importation of a controlled drug, contrary to Article 77(b) of the Customs and Excise (General Provisions) (Jersey) Law, 1972):

Count 1: cannabis resin;

Count 2: amphetamine sulphate.

AGE: 27.

PLEA: Guilty.

DETAILS OF OFFENCE:

Imported 2.39kg cannabis (street value £14,000) concealed in car [count 1] and 568 mg. amphetamine in underpants [count 2]. Courier for the cannabis. Amphetamine a personal amount. Guilty plea virtually inevitable. Did not name supplier.

DETAILS OF MITIGATION:

Married with two small children. Trying to patch up marriage. Offered trip to Jersey with wife plus some spending money. Was a drug user with previous debts. Easy target. After agreeing, minded to pull out but scared to. Frank in interview. Remorse, especially on account of children who were missing him. Did not stand to make large amount.

PREVIOUS CONVICTIONS:

Many for dishonesty, none for drugs.

CONCLUSIONS

count 1: 31/2 years' imprisonment.

count 2: 1 month's imprisonment, concurrent.

SENTENCE AND OBSERVATIONS OF THE COURT:

If there were no couriers there would be no dealers. Greater mitigation allowed by Court than by Crown for guilty plea. Count (1) 3 years other wise conclusions granted.

JUDGMENT

THE BAILIFF: Peter Moore has pleaded guilty to the fraudulent evasion of the prohibition on importation of controlled drugs by importing cannabis resin and amphetamine sulphate.

The facts are that the drugs were found in the back of a car driven by the defendant upon his arrival at the harbour. The packages concealed in the back of the car contained a total of 2.39 kilograms of cannabis resin. They had been covered by a green washing-up liquid and powder with the intention, in the view of the investigating officers, of making it more difficult for the drugs to be detected by sniffer dogs. The value of the drugs was in the region of £14,400. Moore's explanation was that he had been asked to carry out this delivery by a man whom he refused to name for fear of reprisals. His reward was said to be some £300 for the tickets for himself and his wife to travel to Jersey and a further unspecified sum which he was to receive when he delivered the drugs in Jersey.

Counsel for Moore put it to us that the defendant was no more than a courier. We accept that he was a courier, but we do not find that to be a particularly compelling piece of mitigation. If there were no couriers, there would be no drugs problem in this Island.

Moore claimed to have made no enquiry as to the nature of the drugs which he was transporting and it must therefore be said that he was fortunate that he was not found to be transporting Class A drugs.

In mitigation the defendant has pleaded guilty to the indictment, although he had of course, in the circumstances of this case, little choice but to do so.

Having regard to the cases laid before us by counsel we feel able to make a slightly greater reduction for the mitigating

factors than has been allowed by the Crown in its conclusions and we accordingly, Moore, sentence you on count 1, to 3 years' imprisonment; on count 2, to 1 month's imprisonment concurrent, making a total of 3 years' imprisonment and we order the forfeiture and destruction of the drugs.
