the applicant was charged with:

1 count of

driving without due care and attention, contrary to Article 15 of the Road Traffic (Jersey)

Law, 1956, as amended (charge 1 of the 1st charge sheet).

1 count of

dangerous or careless driving, contrary to Article 26 (2) of the said Law (charge 2 of the

1st charge sheet).

of assault (charge 1 of 2nd charge sheet).

1 count of 4 counts of

grave and criminal assault (charges 2,3,4, & 5 of 2nd charge sheet).

1 count of

acting in a manner likely to cause a breach of the peace (charge 6 of the 2nd charge

sheet); and

3 counts of

causing malicious damage (charges 7,8 & 9 of 2nd charge sheet)

On 13th April, 1995,

the applicant after pleading guilty to charges 1 & 2 of 1st charge sheet, and to charges 1, 6 & 9 of 2nd charge sheet, and not guilty to the remaining

charges, was tried and convicted.

On 11th May, 1995,

the applicant was sentenced to a total of 2 months' imprisonment, but aplied for bail, pending appeal out of time aginst conviction and against concurrent sentences of 2 months' imprisonment, imposed on charges 2-5 inclusive of 2nd charge sheet and of 2 weeks' imprisonment imposed on charges 7 & 8 of

2nd charge sheet. Bail was refused.

## JUDGMENT

DEPUTY BAILIFF: This is an application by Jason Thomas Russell for bail, pending appeal from a decision of the Relief Magistrate. The appeal against conviction is three weeks out of time.

Mr. Russell was sentenced yesterday o two months' imprisonment. No reason was given to us why the appeal against conviction was delayed. The charges all arise out of the same incident, where serious injury could have resulted.

The applicant drove his car at another car with four persons in it, in the presence of the police. It was a domestic problem, but injury and shock resulted.

The application is hopeless. Mr. Livingstone says the words of Judge Short show that the matter was not properly considered. What Judge Short, who had knowledge of the case, said was this:

"All the grounds are there clearly set out before me. Bail pending appeal is more sparingly granted than bail before the finding. If it had been a matter of two or three days, or even two or three weeks, and if I had felt any danger that the appeal would not come up for hearing before the end of the sentence of before the mid-sentence, I would have considered it. But I am not willing to grant bail in this instance because I think it would be wrong in principle".

It cannot be right that every comparatively short sentence where an appeal is made, leads to a successful bail application. As the learned Attorney has said, the Magistrates have to exercise a delicate balancing operation, and in the duty that we have in this Court, we can see no reason, in this case, to interfere.

Therefore, the application is refused.
