 - (2) By consent of the relevant parties, the Industrial Tribunal orders a protective award of 60 days' pay in respect of all pilots falling within the recognised bargaining unit which are listed in Schedule 1 (attached) beginning on the date of their dismissal.
 - (3) Subject to the normal categories of preferential debts set out in Schedule 6 of the Insolvency Act 1986, any payments made by the respondent (rather than the Secretary of State) pursuant to this judgment will be paid as an unsecured dividend.
 - (4) No Order as to costs.
