# The Parking Places (Disabled Persons’ Vehicles) (Amendment) Order (Northern Ireland) 2010 

Made

11th August 2010
Coming into operation -
1st September 2010

The Department for Regional Development(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the parts of the roads specified in the Schedules.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

Sixteen objections were received and duly considered and no other representations were received.

The Department has modified the draft Order.

## Citation and commencement

1. This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment) Order (Northern Ireland) 2010 and shall come into operation on 1st September 2010.

## Amendments

2.-(1) The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2006(a) shall be amended in accordance with paragraphs (2) to (8).
(2) In Article 2 (authorisation of parking places) for the words "Schedules 1, 2, 3, 4 and 5" substitute the words "Schedules 1, 2, 3, 4, 5 and 6".
(3) After Article 3AB insert the following Article-
"3AC. Except as set out in Article 4, the driver of a disabled persons' vehicle shall not permit it to wait in a parking place specified in Schedule 6 for longer than 3 hours between the hours of $8.00 \mathrm{a} . \mathrm{m}$. and 6.00 p.m. on any day from Monday to Saturday.".
(4) After Article 3D insert the following Article-
"3E. Except as set out in Article 4, where a disabled persons’ vehicle has waited in a parking place specified in Schedule 6 between the hours of $8.00 \mathrm{a} . \mathrm{m}$. and $6.00 \mathrm{p} . \mathrm{m}$. on any day from Monday to Saturday, then the driver of that vehicle shall not permit it to return to that parking place until the period of 1 hour has elapsed since the previous period of waiting or until 6.00 p.m., whichever is the shorter period.".

18. Thomas Street, Armagh (east side) - from a point 15 metres north of its junction with Dobbin Street for distance of 5.5 metres."

2. Market Square North, Lisburn (south side) - from a point 15 metres east of its junction with Market Square West for a distance of 28 metres.
3. Sloan Street, Lisburn (north side) - from a point 41 metres east of its junction with Gregg Street for a distance of 9 metres."

## EXPLANATORY NOTE

(This note is not part of the Order)
This Order amends The Parking Places (Disabled Persons’ Vehicles) Order (Northern Ireland) 2006 and The Parking Places on Roads (Disabled Persons’ Vehicles) Order (Northern Ireland) 2006.

The amendments provide for the introduction of parking places with unlimited waiting on the parts of the road specified in Schedule 1 and parking places with limited waiting on parts of the road specified in Schedules 2, 3 and 4 to this Order; the removal of the parking places referred to in Articles 2(6)(a) and 3(2)(a); and the substitution of the items referred to in Articles 2(6)(b) and 3(2)(b).
