**The Drumnabreeze Road and Lough Road, Gamblestown,
Donaghcloney (Abandonment) Order (Northern Ireland) 2011**

Made - - - - *12th December 2011*

Coming into operation - *15th February 2012*

The Department for Regional Development^(a) makes the following Order in exercise of the powers conferred by Article 68(1) and (5) of the Roads (Northern Ireland) Order 1993^(b) and now vested in it^(c).

The Department in accordance with Article 68(4) of that Order proposes on the completion of works providing alternative facilities for road traffic, to abandon the areas of road described in the Schedule.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

Citation, commencement and interpretation

1.—(1) This Order may be cited as The Drumnabreeze Road and Lough Road, Gamblestown, Donaghcloney, (Abandonment) Order (Northern Ireland) 2011 and shall come into operation on 15th February 2012.

(2) In this Order “the Developer” means Gamblestown LLP whose registered office is situate c/o 228 Dromore Road, Donaghcloney, BT66 7NP.

Application

2. The Developer shall carry out such works as the Department considers necessary for the provision of alternative facilities for road traffic and on the completion of such works the areas of road described in the Schedule shall be abandoned.

3.—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned areas of road shall be retained.

(2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.

SCHEDULE

Article 2

AREAS OF ROAD TO BE ABANDONED

An area of 340 square metres of Drumnabreeze Road from its junction with Lough Road extending in a north-easterly direction;

An area of 242 square metres of Drumnabreeze Road from its junction with Lurgan Road extending in a north-easterly direction; and

An area of 22 square metres of Lough Road at the south side of its junction with Drumnabreeze Road extending in an easterly direction.

All the areas of road are in the townland of Gamblestown, Donaghcloney and are more particularly delineated and shown hatched on Map No. 10/1/25/10.

A copy of the map has been deposited at the Department's Roads Service offices, Headquarters, Room 213 Clarence Court, 10-18 Adelaide Street, Belfast; and Southern Division, Marlborough House, Central Way, Craigavon.
