ROAD TRAFFIC AND VEHICLES

The Parking Places (Disabled Persons' Vehicles) (Amendment No. 3) Order (Northern Ireland) 2014

Made - - - - 11th June 2014

Coming into operation - 1st July 2014

The Department for Regional Development(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedules.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objections or other representations have been received.

The Department has modified the draft Order.

Citation and commencement

1. This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment No. 3) Order (Northern Ireland) 2014 and shall come into operation on 1st July 2014.

Article 2(4)

Waiting Limited to 2 hours Monday to Saturday between 8.30 a.m. and 6.15 p.m. with return prohibited within 3 hours.

"5. Kildare Street, Newry (south side) (2 bays) – from a point 29 metres east of its junction with Hill Street, for a distance of 4.8 metres in an easterly direction."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2006 and The Parking Places on Roads (Disabled Persons' Vehicles) Order (Northern Ireland) 2006.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of road specified in Schedule 1, the introduction of parking places with limited waiting on the lengths of the roads specified in Schedule 2 and Schedule 3 and the removal of the parking places referred to in Articles 2(2)(a), 2(3)(a) and 3(2).

This Order also amends The On-Street Parking Order (Northern Ireland) 2000 by redefining the parking place in Kildare Street, Newry to exclude a length of that road (Article 4).
