ROAD TRAFFIC AND VEHICLES

The Control of Traffic (Belfast City Centre) Order (Northern Ireland) 2014

Made - - - - 30th September 2014

Coming into operation - 21st October 2014

The Department for Regional Development(a) makes the following Order in exercise of the powers conferred by Articles 4(1), (2) and (3), 10(4) and 13(1), (13) and (16) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of road specified in Schedule 4.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedules 1 and 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of those Schedules.

The Department, in compliance with paragraph 3(4) of Schedule 4 to that Order, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Control of Traffic (Belfast City Centre) Order (Northern Ireland) 2014 and shall come into operation on 21st October 2014.

- (2) Delete item no. 11, relating to the eastern side of the northbound carriageway of Great Victoria Street, Belfast and item no. 12, relating to the southern side of the carriageway of Grosvenor Road, Belfast.

Article 5

No Waiting 8.00 a.m. to 6.00 p.m., Monday to Saturday

- "6. Grosvenor Road, Belfast (south side) from a point 15 metres east of its junction with Durham Street to a point 15 metres west of its junction with Great Victoria Street.
- 7. Grosvenor Road, Belfast (north side) from a point 15 metres east of its junction with Durham Street to a point 15 metres west of its junction with Athol Street.
- 8. Grosvenor Road, Belfast (north side) from a point 15 metres east of its junction with Athol Street to a point 15 metres west of its junction with Fisherwick Place."

SCHEDULE 2

Article 10(2)(ii)

No Waiting at any Time (loading and unloading permitted)

- "23. Adelaide Street (east side) from a point 10 metres south of its junction with May Street to a point 23 metres south of that junction.
- 24. Chichester Street (north side) from a point 24 metres west of its junction with Montgomery Street to a point 32 metres west of that junction.
- 25. College Square North (south side) from a point 15 metres west of its junction with College Square East to a point 20.5 metres west of that junction."

No Waiting at any Time (including no loading or unloading)

"8. Great Victoria Street (east side) – from a point 15 metres south of its junction with Howard Street to a point 23 metres south of that junction."

Waiting only between 9.30 a.m. and 7.00 p.m. on Monday to Saturday limited to 4 hours – no return within 1 hour

All in Belfast

- 1. College Square North (north side) from a point 38 metres west of its junction with College Place North for a distance of 55 metres in a westerly direction.
- 2. College Square North (south side) from a point 20.5 metres west of its junction with College Square East for a distance of 56 metres in a westerly direction."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order will adjust the traffic management arrangements in Belfast City Centre.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of Article 9, and any provision relating to parking places and the waiting restrictions in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Any person who acts in contravention of Article 7(3) and any provision relating to cycle tracks shall be guilty of an offence under the Road Traffic Regulation (Northern Ireland) Order 1997 ("the Regulation Order") and shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale (£1,000) in accordance with The Road Traffic Offenders (Northern Ireland) Order 1996 as amended by the Regulation Order.

Traffic signs indicating the effect of this Order will in due course be placed on the roads.
