The Taxis (Lisburn) Order (Northern Ireland) 2015

Made - - - - 18th May 2015

Coming into operation - 8th June 2015

The Department for Regional Development(a) makes the following Order in exercise of the powers conferred by Article 27A(1) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4A to that $Order(\mathbf{d})$.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as The Taxis (Lisburn) Order (Northern Ireland) 2015 and shall come into operation on 8th June 2015.
 - (2) In this Order—

"taxi" has the meaning given in Article 27A(4) of the Road Traffic Regulation (Northern Ireland) Order 1997.

Location and number of taxis

2. No stand for taxis shall be used except one specified in column 2 of Schedule 1 in relation to the location specified opposite thereto in column 1, their number shall not exceed that specified in column 3 and the hours available for use shall be as stated in column 4.

Use of stands or starting places

3. No vehicle other than a taxi shall use the stands specified in column 2 of Schedule 1 at any time.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order prescribes the precise locations which may be used as stands for taxis in the city of Lisburn, the maximum number of taxis which may use each stand and hours available for use. The Order also prohibits vehicles other than taxis from using the stands.

The Order also revokes previous legislation creating stands for taxis in Lisburn.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.
