The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Prohibition of Waiting (Amendment) Order (Northern Ireland) 2015 and shall come into operation on 22nd June 2015.

Amendment

2. The Prohibition of Waiting Order (Northern Ireland) 2001(**d**) is amended by the addition to Schedule 2 of the items specified in the Schedule to this Order.
