# The Parking and Waiting Restrictions (Belfast) (Amendment No. 3) Order (Northern Ireland) 2015

Made---8th July 2015Coming into operation-28th July 2015

The Department for Regional Development(**a**) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3), 10(4) and 13(1) of the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of road specified in Article 2(2).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedules 1 and 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of those Schedules.

The Department, in compliance with paragraph 3(4) of Schedule 4 to that Order, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

### Citation and commencement

This Order may be cited as The Parking and Waiting Restrictions (Belfast) (Amendment No.
Order (Northern Ireland) 2015 and shall come into operation on 28th July 2015.

#### Amendment

**2.**—(1) The Parking and Waiting Restrictions (Belfast) Order (Northern Ireland)  $2008(\mathbf{a})$  is amended in accordance with paragraphs (2) to (5).

(2) Part II of Schedule 1 is amended by the addition to of the following items-

- "11. Finaghy Road South (in a lay-by) (south-west side) from a point 47 metres southeast of its junction with Upper Lisburn Road for a distance of 22 metres in a southeasterly direction.
- 12. Mount Aboo Park (in a lay-by) (north-east side) from a point 13 metres south-east of its junction with Upper Lisburn Road for a distance of 19 metres in a south-easterly direction.
- 13. Upper Lisburn Road (in a lay-by) (north-west side) from a point 3 metres southwest of its junction with Grangeville Drive for a distance of 34 metres in a southwesterly direction.
- 14. Upper Lisburn Road (in a lay-by) (north-west side) from a point 58 metres northeast of its junction with Finaghy Road North for a distance of 27 metres in a northeasterly direction.
- 15. Upper Lisburn Road (in a lay-by) (north-west side) from a point 17 metres northeast of its junction with Finaghy Road North for a distance of 36 metres in a northeasterly direction.
- 16. Upper Lisburn Road (in a lay-by) (north-west side) from a point 21 metres southwest of its junction with Finaghy Road North for a distance of 43 metres in a southwesterly direction.
- 17. Upper Lisburn Road (in a lay-by) (south-east side) from a point 31 metres southwest of its junction with Finaghy Road South for a distance of 47 metres in a southwesterly direction.
- 18. Upper Lisburn Road (in a lay-by) (south-east side) from a point 35 metres northeast of its junction with Finaghy Road South for a distance of 47 metres in a northeasterly direction.
- 19. Upper Lisburn Road (in a lay-by) (south-east side) from a point 26 metres northeast of its junction with Mount Aboo Park for a distance of 17 metres in a northeasterly direction.
- 20. Upper Lisburn Road (in a lay-by) (south-east side) from a point 48 metres northeast of its junction with Mount Aboo Park for a distance of 7 metres in a northeasterly direction."
- (3) Item no. 2 of Part III of Schedule 1 is deleted.
- (4) Part I of Schedule 2 is amended by the addition to of the following items—
  - "36. Cadogan Park, Belfast (south side) from a point 15 metres west of its junction with Malone Road for a distance of 15 metres in a westerly direction.
  - 37. Exchange Place, Belfast (both sides) from a point 15 metres north-east of its junction with Donegall Street to a point 15 metres south-west of its junction with Hill Street.
  - 38. Wellington Court, Belfast (north side) from a point 10 metres south of its junction with Wellington Street for a distance of 28 metres in a westerly direction.
  - 39. Wellington Court, Belfast (south side) from a point 15 metres south of its junction with Wellington Street for a distance of 28 metres in a westerly direction."

#### **EXPLANATORY NOTE**

### (This note is not part of the Order)

This Order amends The Parking and Waiting Restrictions (Belfast) Order (Northern Ireland) 2008 ("the Order") by the addition to Part II of Schedule 1 of the items specified in Article 2(2) and the deletion from Part III of Schedule 1 of the item relating to Mount Aboo Park (Article 2(3)).

The Order also prohibits vehicles waiting on the lengths of road specified in Article 2(4) at any time and no waiting between 8.00 a.m. and 6.00 p.m. Monday to Saturday on the length of road specified in Article 2(5).

Vehicles are excepted from the conditions and prohibition in certain circumstances.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the roads.
