ROAD TRAFFIC AND VEHICLES

The Parking Places on Roads (Disabled Persons' Vehicles) (Amendment No. 2) Order (Northern Ireland) 2015

Made - - - - 17th July 2015

Coming into operation - 6th August 2015

The Department for Regional Development(\mathbf{a}) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) and 15(1) of the Road Traffic Regulation (Northern Ireland) Order 1997(\mathbf{b}) and now vested in it(\mathbf{c}).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedules.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objections or other representations have been received.

Citation and commencement

1. This Order may be cited as The Parking Places on Roads (Disabled Persons' Vehicles) (Amendment No. 2) Order (Northern Ireland) 2015 and shall come into operation on 6th August 2015.

Amendments

- (3) In Article 3(a) (Use as parking places) for the words "Schedules 1, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12 or 14;" substitute "Schedules 1, 4, 5, 6, 7, 9, 10, 11, 12, or 14".
 - (4) In Article 4 delete paragraphs (a) and (f).
 - (5) In Article 5 delete paragraphs (a) and (f).
 - (6) In Schedule 1—
 - (a) Delete the following items—
 - (i) item no. 36 relating to Massereene Street, Antrim;
 - (ii) item no. 125 relating to Drumtara, Ballee, Ballymena;
 - (iii) item no. 456 relating to Kimona Drive, Belfast;
 - (iv) item no. 496 relating to Ohio Street, Belfast;
 - (v) item no. 1267 relating to Bow Street, Lisburn; and
 - (vi) item no. 1324 relating to Clarence Avenue, Londonderry.
 - (b) Add the items set out in Schedule 1 to this Order.
 - (c) For item no. 1496 substitute the following item—

"The Diamond, Moy (south-west side) – from a point 108 metres south-east of its junction with Benburb Road, for a distance of 5 metres in a south-easterly direction."

- (7) Delete Schedule 3.
- (8) For Schedule 7 substitute the Schedule set out in Schedule 2 to this Order.
- (9) Delete Schedule 8.

Parking Places Amendments

- **3.** The Parking Places on Roads (Kesh) Order (Northern Ireland) 2010(a) is amended by the substitution for the Schedule of the Schedule set out in Schedule 3 to this Order.
- **4.** The On-Street Parking Order (Northern Ireland) 2000(**b**) is amended by the substitution for item 46 of Chapter 1, Part 1 of Schedule 1 of the same description together with a new map.

- 2257. Orangefield Drive, Armagh (south side) from a point 73 metres north-east of its junction with Ballynahone Avenue, for a distance of 6 metres in an easterly direction.

- 4. Bridge Street, Lisburn (north side) from a point 105 metres east of its junction with Market Square, for a distance of 6 metres.
- 5. Castle Street, Lisburn (north side) from a point 65 metres east of its junction with Railway Street, for a distance of 6 metres.
- 6. Castle Street, Lisburn (north side) from a point 120 metres east of its junction with Railway Street, for a distance of 6 metres.

- 14. Market Square South, Lisburn (north side) from a point 20 metres west of its junction with Market Square East, for a distance of 31.1 metres in a westerly direction.
- 15. Market Street, Lisburn (east side) from a point 45.5 metres south of its junction with Market Square South, for a distance of 6.6 metres in a southerly direction.
- 16. Railway Street, Lisburn (west side) from a point 10 metres north of its junction with Market Square, for a distance of 10 metres.
- 17. Sloan Street, Lisburn (north side) from a point 41 metres east of its junction with Gregg Street, for a distance of 9 metres.
- 18. Smithfield Street, Lisburn (south side) from a point 72 metres east of its junction with Barrack Street, for a distance of 6 metres."

"SCHEDULE

Parking Places in Kesh - Monday to Saturday 8.30 a.m. to 6.30 p.m., Maximum stay 1 hour; No return within 1 hour;

- 1. Main Street, (south-west side) from a point 58.5 metres south-east of its junction with Crevenish Road, extending in a south-easterly direction for a distance of 10.5 metres.
- 2. Main Street, (south-west side) from a point 75 metres south-east of its junction with Crevenish Road, extending in a south-easterly direction for a distance of 37.5 metres.
- 3. Main Street, (south-west side) from a point 122.5 metres south-east of its junction with Crevenish Road, extending in a south-easterly direction for a distance of 28 metres."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places on Roads (Disabled Persons' Vehicles) Order (Northern Ireland) 2015 by the introduction of parking places with unlimited waiting on the lengths of the roads specified in Schedule 1, the introduction of parking places with limited waiting on the lengths of roads specified in Schedule 2, the substitution of the item referred to Article 2(6)(c) and the removal of the parking places referred to in Article 2(6)(a), (7) and (9).

The Order also amends The Parking Places on Roads (Kesh) Order (Northern Ireland) Order 2010 by the substitution for the parking places of those specified in Schedule 3.

The Order also amends The On-Street Parking Order (Northern Ireland) 2000 by redefining the parking place in Gloucester Street, Belfast to exclude a length of that road (Article 4).
