ROAD TRAFFIC AND VEHICLES

The Parking Places on Roads (Disabled Persons' Vehicles) (Amendment No. 3) Order (Northern Ireland) 2015

Made - - - - 26th November 2015

Coming into operation - 16th December 2015

The Department for Regional Development(**a**) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

Two objections have been received and duly considered and no other representations were received.

The Department has modified the draft Order.

Citation and commencement

1. This Order may be cited as The Parking Places on Roads (Disabled Persons' Vehicles) (Amendment No. 3) Order (Northern Ireland) 2015 and shall come into operation on 16th December 2015.

 "Beechfield Drive, Donaghadee (west side) (2 bays) from a point 55 metres south of its western junction with Cannyreagh Road, for a distance of 6.1 metres in a southerly direction."
 - (b) For item no. 1105 substitute the following item—
 "Trevor Street, Holywood (south-west side) (2 bays) from a point 23 metres south-east of its junction with Church View, for a distance of 11 metres in a south-easterly direction."
 - (c) For item no. 2011 substitute the following item—
 "Cuan Avenue, Portaferry (west side) (2 bays) from a point 101 metres north-west of its junction with Park Head, for a distance of 7.3 metres in a south-westerly direction."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places on Roads (Disabled Persons' Vehicles) Order (Northern Ireland) 2015.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of road specified in the Schedule, the removal of the parking places referred to in Article 2(2) and the amendment of the items specified in Article 2(4).
