The Attorney General's Human Rights Guidance (Youth Justice Agency – Conditions of Detention) Order (Northern Ireland) 2015

Made - - - - *12th February 2015*

Coming into operation - *23rd March 2015*

The Attorney General:

- (a) has, in pursuance of section 8(1) of the Justice (Northern Ireland) Act 2004, issued guidance on international human rights standards in respect of the Department of Justice (functions of the Department^(a) exercised by the Youth Justice Agency);
- (b) has, in accordance with section 8(3)(a) of the Justice (Northern Ireland) Act 2004, published that guidance on his website;
- (c) has, in accordance with section 8(3)(b) of that Act, laid that guidance before the Assembly^(b);
- (d) has, in accordance with section 8(1A) and section 8(5A) of that Act, consulted the Advocate General for Northern Ireland^(c).

The Attorney General, in exercise of the powers conferred by section 8(3)(c) of that Act, makes the following order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Attorney General's Human Rights Guidance (Youth Justice Agency – Conditions of Detention) Order (Northern Ireland) 2015 and shall come into operation on 23rd March 2015.

(2) The Interpretation Act (Northern Ireland) 1954 shall apply to this Order as it applies to an Act of the Assembly^(d).

Coming into operation of the guidance

2. The guidance on international human rights standards in respect of the Department of Justice (functions exercised by the Youth Justice Agency) shall come into operation on the day on which this Order comes into operation.
