The Parking Places on Roads (Disabled Persons' Vehicles) (Amendment) Order (Northern Ireland) 2016

Made	-	8th February 2016
Coming into operation	-	29th February 2016

The Department for Regional Development(**a**) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No objections or other representations have been received.

Citation and commencement

1. This Order may be cited as The Parking Places on Roads (Disabled Persons' Vehicles) (Amendment) Order (Northern Ireland) 2016 and shall come into operation on 29th February 2016.

Unlimited Waiting

- "2324. Caulside Park, Antrim (south-west side) (to the side of No. 12) from a point 137 metres north-west of its junction with Newpark Road South, for a distance of 5.5 metres in a westerly direction.
- 2325. Queens Road, Antrim (east side) from a point 212 metres south of its junction with Parkhall Road, for a distance of 5.5 metres in an easterly direction.
- 2326. Belmont Road, Belfast (south side) from a point 44 metres east of its junction with Belmont Avenue West, for a distance of 5.5 metres in an easterly direction.
- 2327. Clarawood Park, Belfast (south-west side) from a point 32 metres south-east of its junction with Clarawood Grove, for a distance of 6.6 metres in a south-easterly direction.
- 2328. Hillview Avenue, Belfast (east side) from a point 15 metres south of its junction with Sinclair Street, for a distance of 5.5 metres in a southerly direction.
- 2329. Northland Row, Dungannon (north-west side) from a point 92 metres southwest of its junction with Killyman Road, for a distance of 6 metres in a southwesterly direction.
- 2330. Drumragh Car Park Link Road, Omagh (north-west side) from a point 53 metres south-west of its junction with Drumragh Avenue, for a distance of 2.5 metres in a south-westerly direction.
- 2331. Drumragh Car Park Link Road, Omagh (north-west side) from a point 58 metres south-west of its junction with Drumragh Avenue, for a distance of 2.5 metres in a south-westerly direction."

This Order amends The Parking Places on Roads (Disabled Persons' Vehicles) Order (Northern Ireland) 2015 by the introduction of parking places with unlimited waiting on the lengths of the roads specified in the Schedule and the removal of the parking place referred to in Article 2(2).
