The Parking Places, Loading Bay and Waiting Restrictions (Newcastle) (Amendment) Order (Northern Ireland) 2017

The Department for Infrastructure(**a**) makes the following Order in exercise of the powers conferred by Articles 10(4) and 13(1) of the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the road specified in Article 2.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department, in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation was received.

Citation and commencement

1. This Order may be cited as The Parking Places, Loading Bay and Waiting Restrictions (Newcastle) (Amendment) Order (Northern Ireland) 2017 and shall come into operation on 21st July 2017.

Amendment

2. The Parking Places, Loading Bay and Waiting Restrictions (Newcastle) Order (Northern Ireland) 2014(**d**) is amended by the addition to Schedule 1 of the following items—

- "4. Central Promenade, Newcastle (west side) from a point 8.5 metres south of its junction with Post Office Lane for a distance of 16 metres in a southerly direction.
- 5. Central Promenade, Newcastle (west side) from a point 30.5 metres south of its junction with Post Office Lane for a distance of 21 metres in a southerly direction."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places, Loading Bay and Waiting Restrictions (Newcastle) Order (Northern Ireland) 2014 by the addition of the parking places on the lengths of road specified in Article 2. Vehicles are excepted from the conditions of using the parking places in certain circumstances.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the road.
