The Parking and Waiting Restrictions (Ballyclare) (Amendment) Order (Northern Ireland) 2017

Made - - - - 23rd August 2017

Coming into operation - 18th September 2017

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Parking and Waiting Restrictions (Ballyclare) (Amendment) Order (Northern Ireland) 2017 and shall come into operation on 18th September 2017.

Amendments

- **2.**—(1) The Parking and Waiting Restrictions (Ballyclare) Order (Northern Ireland) 2017(**d**) is amended in accordance with paragraphs (2) and (3).
 - (2) For Article 12(c) substitute the following—
 - "(c) between the hours of 8.00 a.m. and 6.00 p.m. on the days Monday to Friday inclusive on the lengths of the roads specified in Part 3 of Schedule 2."

(3) For Part 3 of Schedule 2 substitute the following—

"PART 3

No Waiting — Monday to Friday 8.00 a.m. to 6.00 p.m. — Loading and unloading permitted

- 1. George Gardens (east side) from a point 19 metres south-east of its junction with George Avenue to a point 15 metres north of its junction with George Close.
- 2. School Street (south-east side) from a point 15 metres south-west of its junction with The Square for a distance of 20 metres in a south-westerly direction."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking and Waiting Restrictions (Ballyclare) Order (Northern Ireland) 2017 ("the Order") by the addition of a no waiting restriction on School Street, Ballyclare. Vehicles are excepted from the prohibition in certain circumstances.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the road.
