# The Schools (Part-Time 20mph Speed Limit) Order (Northern Ireland) 2018

Made - - - - 29th August 2018

Coming into operation - 18th September 2018

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 38(1) and (2) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 5 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

#### Citation and commencement

**1.** This Order may be cited as The Schools (Part-Time 20mph Speed Limit) Order (Northern Ireland) 2018 and shall come into operation on 18th September 2018.

#### Part-time speed limit

- 2.—(1) A person shall not drive a motor vehicle on a length of road specified in the Schedule at a speed exceeding 20 miles per hour when such speed limit applies to that length of road in accordance with paragraph (2).
- (2) A 20 miles per hour speed limit applies to the lengths of road specified in the Schedule when a 20 miles per hour speed limit is indicated by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations (Northern Ireland) 1997(**d**) or a traffic sign illustrated in Diagram E or Diagram F of the traffic signs authorisation made by the Department on 9th February 2017.

### Revocations

**3.** The Orders specified in Schedule 3 are revoked.

### PART-TIME SPEED LIMITS

- 1. Carrickmannon Road, Route C272, Ballygowan, from a point 115 metres north-west of its junction with New Line Road, Unclassified No. 266, for a distance of 472 metres in a north-westerly direction.
- 2. Benvardin Road, Route B67, Ballybogey, Ballymoney, from its junction with Conogher Road, to a point 160 metres west of Kilmoyle Road.
- 3. Finvoy Road, Route B62, Ballymoney, from a point 270 metres south of its junction with Drumlee Road, Unclassified No. 138, for a distance of 310 metres in a southerly direction.
- 4. Ballynaskeagh Road, Route B3, Banbridge, from a point 84 metres north-west of its junction with Glasker Court, to a point 231 metres south-east of that junction.
- 5. Belfast Road, Route A2, Carrickfergus, from a point 180 metres north-east of its junction with Windmill Avenue, Unclassified No. 3102, to a point 210 metres south-west of that junction.
- 6. College Lands Road, Route B28, Charlemont, from a point 190 metres north-west of its junction with Corrigan Hill Road, Unclassified No. 7461, to a point 280 metres south-east of that junction.
- 7. Concession Road, Route A37, Clonalig, from a point 1456 metres south-east of its junction with Culloville Road, Route B30, for a distance of 435 metres in a south-easterly direction.
- 8. Ballywoolen Road, Unclassified No. 331, Articlave, Coleraine, from its junction with Mussenden Road, Route A2, for a distance of 137 metres in an easterly direction.
- 9. Mussenden Road, Route A2, Articlave, Coleraine, from a point 83 metres north-west of its junction with Ballywoolen Road, Unclassified No. 331, for a distance of 354 metres in a south-easterly direction.
- 10. Curragh Road, Route A54, Coleraine, from its junction with Knockaduff Road, Unclassified No. 344, for a distance of 320 metres in a southerly direction.
- 11. Ballyhay Road, Unclassified No. 112, Donaghadee, from its junction with Killaughey Road, Route C253, to a point 60 metres north-west of that junction.
- 12. Ballyvester Road, Unclassified No. 283, Donaghadee, from its junction with Killaughey Road, Route C253, to a point 130 metres south-east of that junction.
- 13. Killaughey Road, Route C253, Donaghadee, from a point 264 metres south-west of its junction with Ballyhay Road, Unclassified No. 112, to a point 200 metres north-east of that junction.
- 14. Derrymore Road, Route B156, Lurgan, from a point 35 metres north of its junction with Bayview Park, Unclassified No. 1021, to a point 150 metres south of that junction.
- 15. Ballyronan Road, Route B160, Magherafelt, from a point 160 metres north-west of its junction with Oaklea Road, Unclassified No. 2226, to a point 120 metres south-east of that junction.
- 16. Oaklea Road, Unclassified No. 2226, Magherafelt, from a point 200 metres north-east of its junction with Ballyronan Road, Route B160, to a point 100 metres south-west of that junction.
- 17. Moyallan Road, Route A50, Portadown, from a point 15 metres west of its junction with Ballynagarrick Road, Unclassified No. 1286, to a point 460 metres south-east of that junction.
- 18. Lylehill Road, Route C27, Templepatrick, Ballyclare, from a point 208 metres south-east of its junction with Old Coach Road, for a distance of 307 metres in a south-easterly direction.

#### **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order introduces a part-time speed limit on the following lengths of road specified in the Schedule—

- 1. Carrickmannon Road, Ballygowan adjacent to Carrickmannon Primary School;
- 2. Finvoy Road, Ballymoney adjacent to Carrowreagh Primary School;
- 3. Ballynaskeagh Road, Banbridge adjacent to Bronte Primary School;
- 4. Belfast Road, Carrickfergus adjacent to the Model Primary School;
- 5. Curragh Road, Coleraine adjacent to Culcrow Primary School;
- 6. Ballyhay Road and Ballyvester Road, Donaghadee adjacent to Ballyvester Primary School;
- 7. Derrymore Road, Lurgan adjacent to St. Marys Primary School, Gawleys Gate, Lurgan; and
- 8. Ballyronan Road and Oaklea Road, Magherafelt adjacent to Woods Primary School.

The Order also revokes and re-enacts part-time speed limits on the following lengths of road—

- 1. Benvardin Road, Ballymoney adjacent to Kilmoyle Primary School;
- 2. College Lands Road, Charlemont adjacent to St. Peter's Primary School, Charlemont;
- 3. Concession Road, Clonalig adjacent to Clonalig Primary School;
- **4.** Ballywoolen Road and Mussenden Road, Articlave, Coleraine adjacent to Hezlett Primary School:
  - 5. Moyallan Road, Portadown adjacent to Moyallon Primary School; and
  - 6. Lylehill Road, Templepatrick adjacent to Templepatrick Primary School.

The Order permits the current speed limit to be reduced to 20 miles per hour when a 20 miles per hour limit is indicated by a traffic sign (Article 2(2)).
