**The Schools (Part-Time 20mph Speed Limit) (Amendment)
Order (Northern Ireland) 2018**

Made - - - - - *3rd December 2018*

Coming into operation - *28th December 2018*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 38(1) and (2) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 5 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representations have been received.

Citation and commencement

1. This Order may be cited as The Schools (Part-Time 20mph Speed Limit) (Amendment) Order (Northern Ireland) 2018 and shall come into operation on 28th December 2018.

Amendments

2. Schedule 1 to The Schools (Part-Time 20mph Speed Limit) Order (Northern Ireland) 2018^(d) is amended by the addition of the following items—

- “19. Ardmore Road, Route C508, Londonderry, from a point 31 metres south-east of its junction with Forge Road, Route C515, to a point 275 metres south-east of that junction.
- 20. Ballougy Hill Road, Unclassified No. 1101, Londonderry, from a point 26 metres north-west of its junction with Mullenan Road, Route A4, to a point 28 metres south-east of that junction.
- 21. Mullenan Road, Route A4, Londonderry, from a point 235 metres south-west of its junction with Ballougy Hill Road, Unclassified No. 1101, to a point 261 metres north-east of that junction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Schools (Part-Time 20mph Speed Limit) Order (Northern Ireland) 2018 by the introduction of a part-time speed limit on lengths of—

1. Ardmore Road, Londonderry adjacent to Glendermott Primary School; and
2. Ballougry Hill Road and Mullenan Road, Londonderry adjacent to Ballougry Primary School.

The Order permits the current speed limit on these lengths of road to be reduced to 20 miles per hour when a 20 miles per hour limit is indicated by a traffic sign.
