# ROAD TRAFFIC AND VEHICLES

The Parking Places, Loading Bays and Waiting Restrictions (Coleraine) (Amendment) Order (Northern Ireland) 2018

Made - - - - 31st January 2018

Coming into operation - 26th February 2018

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

### Citation and commencement

**1.** This Order may be cited as The Parking Places, Loading Bays and Waiting Restrictions (Coleraine) (Amendment) Order (Northern Ireland) 2018 and shall come into operation on 26th February 2018.

## Amendment

- **2.** The Parking Places, Loading Bays and Waiting Restrictions (Coleraine) Order (Northern Ireland) 2011(**d**) is amended by the addition to Part 1 of Schedule 2 of the following item—
  - "141. Hillman's Way (east side) from a point 15 metres south of its junction with Ballycastle Road for a distance of 92 metres in a southerly direction."

This Order amends The Parking Places, Loading Bays and Waiting Restrictions (Coleraine) Order (Northern Ireland) 2011 ("the Order") by the addition of a no waiting at any time (loading and unloading permitted) restriction on a length of Hillman's Way, Coleraine as specified in Article 2.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the road.
