**The Roads (Speed Limit) (No. 3) Order (Northern Ireland) 2019**

*Made* - - - - *2nd December 2019*

*Coming into operation* - *23rd December 2019*

The Department for Infrastructure<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Articles 37(3), 37(4) and 38(1)(a) of the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 5 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objections or other representations have been received.

**Citation and commencement**

1. This Order may be cited as The Roads (Speed Limit) (No. 3) Order (Northern Ireland) 2019 and shall come into operation on 23rd December 2019.

**Application of speed limits**

2. The driving of motor vehicles at a speed exceeding 40 miles per hour on the road and lengths of road specified in Schedule 1 is prohibited.

3. The driving of motor vehicles at a speed exceeding 50 miles per hour on the road and lengths of road specified in Schedule 2 is prohibited.

**Revocations**

4. The provisions described in Schedule 3 are revoked.

## SCHEDULE 1

Article 2

### Road and lengths of road subject to a speed limit of 40 miles per hour

1. Hannahstown Hill, Unclassified No. 0800, Belfast, for its entire length.
2. Cornakinnegar Road, Route B12, Lurgan, from a point 175 metres north-east of its junction with North Circular Road, Unclassified No. 1409, to a point 120 metres north of its junction with Tarry Lane, Unclassified No. 1409, in a northerly direction.
3. Lisky Road, Route B0072, Victoria Bridge, Strabane, from a point 230 metres north of its junction with Conthem Road, Unclassified No. 2028, to a point 120 metres south of that junction.

## SCHEDULE 2

Article 3

### Road and lengths of road subject to a speed limit of 50 miles per hour

1. Upper Springfield Road, Route B38, Belfast, from its junction with Monagh Bypass, Route A55, to a point 144 metres south-east of its junction with Hannahstown Hill, Unclassified No. 0800.
2. Ballycastle Road Roundabout, Route A29, Coleraine, for its entire length.
3. Ballyrashane Road, Route B67, Coleraine, from its junction with Ballycastle Road Roundabout, Route A29, to a point 370 metres east of that junction.
4. Ring Road, Route A29, Coleraine, from its junction with Ballycastle Road Roundabout, Route A29, to a point 530 metres north of that junction.

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order—

- (a) applies a speed limit of 40 miles per hour to the road and lengths of road specified in Schedule 1;
- (b) applies a speed limit of 50 miles per hour to the road and lengths of road specified in Schedule 2; and
- (c) revokes the provisions in Schedule 3.

In relation to the revoked provisions in Schedule 3—

**1.** The speed limit on the lengths of Old Warrenpoint Road, Newry (paragraphs 1 and 2 of Schedule 3 is now 30 miles per hour (restricted by street lighting).

**2.** The speed limit on the entire length of Hannahstown Hill, Belfast (items 18 and 19 of paragraph 3 of Schedule 3) is now set at 40 miles per hour.

**3.** The speed limits on the lengths of Upper Springfield Road, Belfast (items 23 and 24 of paragraph 3 of Schedule 3) are now included in a longer length of road set at 50 miles per hour.

**4.** The speed limit on the entire length of Ballycastle Road Roundabout, Coleraine (item 87 of paragraph 4 of Schedule 3) is now set at 50 miles per hour.

**5.** The speed limit on the length of Ballyrashane Road, Coleraine (item 89 of paragraph 4 of Schedule 3) is now included in a longer length of road set at 50 miles per hour.

**6.** The speed limits on the lengths of Camus Road, Douglas Bridge, Strabane (items 133 and 135 of paragraph 5 of Schedule 3) are now 30 miles per hour (restricted by street lighting).

**7.** The speed limit on the length of Lisky Road, Victoria Bridge, Strabane (item 393 of paragraph 5 of Schedule 3) is now included in a longer length of road set at 40 miles per hour.

**8.** The speed limit on the length of Cornakinnegar Road, Lurgan (paragraph 6 of Schedule 3) is now included in a longer length of road set at 40 miles per hour.

**9.** The speed limit on the length of the Ring Road, Route A29, Coleraine (paragraph 7 of Schedule 3) is now set at 50 miles per hour.
