The Department for Infrastructure(**a**) makes the following Order in exercise of the powers conferred by Article 68(1) and (5) of The Roads (Northern Ireland) Order $1993(\mathbf{b})$ and now vested in it(**c**).

The Department in accordance with Article 68(4) of that Order proposes on the completion of works providing alternative facilities for road traffic to abandon the area of road described in the Schedule.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

Citation, commencement and interpretation

1.—(1) This Order may be cited as The Craigs Road, Carrickfergus (Abandonment) Order (Northern Ireland) 2020 and shall come into operation on 3rd July 2020.

(2) In this Order "the Developer" means Blueacta Limited whose registered office is situated at 41 Circular Road, Jordanstown, Newtownabbey, BT37 0RB.

Application

2. The Developer shall carry out such works as the Department considers necessary for the provision of alternative facilities for road traffic and on the completion of the works the area of road described in the Schedule shall be abandoned.

3.—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned area of road shall be relocated.

(2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be extinguished.

Article 2

AREA OF ROAD TO BE ABANDONED

An area of 80 square metres of footpath at Craigs Road, Carrickfergus commencing at a point 3 metres north of its junction with Prince Andrew Way, Carrickfergus to the rear of No. 7 Broadlands Park and extending for a distance of 40 metres in a north-easterly direction along the side boundary of No. 123 Craigs Road more particularly delineated and shown cross-hatched and coloured red on map number IN1/19/251345.
