ROAD TRAFFIC AND VEHICLES

The Parking Places (Disabled Persons' Vehicles) (Amendment No. 3) Order (Northern Ireland) 2021

Made - - - - 3rd February 2021

Coming into operation - 24th February 2021

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment No. 3) Order (Northern Ireland) 2021 and shall come into operation on 24th February 2021.

Amendment

SCHEDULE Article 2

Unlimited Waiting

"2891.	William Street, Crossgar (west side) - from a point 36 metres south of its junction with Killyleagh Street for a distance of 5.5 metres in a southern direction.
2892.	Cardinal O'Fiaich Square, Crossmaglen (north-east side) - from a point 15 metres north-west of its junction with Carlingford Road for a distance of 6 metres in a north-westerly direction.
2893.	Cardinal O'Fiaich Square, Crossmaglen (north-east side) - from a point 110 metres north-west of its junction with Carlingford Road for a distance of 6 metres in a north-westerly direction.
2894.	Cardinal O'Fiaich Square, Crossmaglen (north-west side in a lay-by) - from a point 11 metres north-east of its junction with North Street for a distance of 6 metres in a north-easterly direction.
2895.	Cardinal O'Fiaich Square, Crossmaglen (south-west side in a lay-by) - from a point 5 metres north-west of its junction with Cullaville Road for a distance of 6 metres in a north-westerly direction.
2896.	North Street, Crossmaglen (north-east side) - from a point 15 metres south-east of its junction with Newry Street for a distance of 6 metres in a south-easterly direction.
2897.	New Bridge Street, Downpatrick (east side in a lay-by) - from a point 14 metres south of its junction with New Bridge Street Roundabout for a distance of 5.5 metres in a southerly direction.
2898.	Main Street, Dundrum (north-west side) - from a point 25 metres south-west of its junction with Manse Road for a distance of 6 metres in a south-westerly direction.
2899.	Glenfada Park, Londonderry (east side to the rear of No. 5) – from a point 48.5 metres north-west and then north-east of its junction with Rossville Street for a distance of 3 metres in a north-easterly direction."

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the roads specified in the Schedule.
