# The Parking Places, Loading Bay and Waiting Restrictions (Randalstown) (Amendment) Order (Northern Ireland) 2021

Made--Sth November 2021Coming into operation-29th November 2021

The Department for Infrastructure(**a**) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

#### Citation and commencement

**1.** This Order may be cited as The Parking Places, Loading Bay and Waiting Restrictions (Randalstown) (Amendment) Order (Northern Ireland) 2021 and shall come into operation on 29th November 2021.

#### Amendment

**2.** The Parking Places, Loading Bay and Waiting Restrictions (Randalstown) Order (Northern Ireland) 2012(**d**) is amended by the addition to Schedule 2 of the following item—

"10. Neillsbrook Road (east side) – from a point 15 metres south of its junction with Blackthorn Way for a distance of 270 metres in a southerly direction."

### **EXPLANATORY NOTE**

#### (This note is not part of the Order)

This Order amends The Parking Places, Loading Bay and Waiting Restrictions (Randalstown) Order (Northern Ireland) 2012 ("the Order") by the addition to Schedule 2 of the item relating to Neillsbrook Road specified in Article 2 to this Order.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the road.
