# The Prohibition of Waiting (Schools) (Amendment) Order (Northern Ireland) 2022

Made - - - - 26th October 2022

Coming into operation - 17th November 2022

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

### Citation and commencement

**1.** This Order may be cited as the Prohibition of Waiting (Schools) (Amendment) Order (Northern Ireland) 2022 and shall come into operation on 17th November 2022.

#### Amendment

**2.** The Prohibition of Waiting (Schools) Order (Northern Ireland) 2021(**d**) is amended by the addition to Schedule 2 of the following item—
