The Department for Infrastructure(**a**) makes the following Order in exercise of the powers conferred by Articles 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No objection or other representation has been received.

Citation and commencement

1. This Order may be cited as the Parking Places on Roads, Loading Bay and Waiting Restrictions (Newcastle) (Amendment) Order (Northern Ireland) 2023 and shall come into operation on 14th July 2023.

Amendments

2.—(1) The Parking Places on Roads, Loading Bay and Waiting Restrictions (Newcastle) Order (Northern Ireland) 2018(**a**) is amended in accordance with paragraphs (2) and (3).

(2) In Article 1(2), for the definitions of "postal packet" and "universal service provider" substitute—

"postal packet" has the same meaning as in section 65(1) of the Postal Services Act $2011(\mathbf{b})$; and

"universal service provider" has the same meaning as in section 65(1) of the Postal Services Act 2011.

(3) In Schedule 3 Part 1 after item no. 11 insert the following items-

- "12. Yacht Club Access/Harbour Slip (north-east side) from its junction with South Promenade for a distance of 72 metres in a southerly direction.
- 13. Yacht Club Access/Harbour Slip (south-west side) from a point 49 metres southwest of its junction with South Promenade for a distance of 28 metres in a southerly and easterly direction.
- 14. Yacht Club Access Road/Harbour Slip (west side) from its junction with South Promenade for a distance of 14 metres in a southerly direction."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places on Roads, Loading Bay and Waiting Restrictions (Newcastle) Order (Northern Ireland) 2018 ("the Order") by the addition to Part 1 of Schedule 3 of the items specified in Article 2 and updates the definitions of "postal packet" and "universal service provider".

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the road.
