# The Parking and Waiting Restrictions (Londonderry) Order (Northern Ireland) 2023 

Made<br>Coming into operation<br>4th October 2023<br>27th October 2023

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Articles 4(1), (2) and (3), 10(4) and 13(1), (13) and (16) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in Schedule 1 to this Order.

The Department has consulted with such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedules 1 and 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of those Schedules.

The Department, in compliance with paragraph 3(4) of Schedule 4 to that Order, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

## Citation, commencement and interpretation

1.-(1) This Order may be cited as the Parking and Waiting Restrictions (Londonderry) Order (Northern Ireland) 2023 and shall come into operation on 27th October 2023.
(2) In this Order-
"medical practitioner" means a registered person within the meaning of the Medical Act 1983(d);
"parking place" means a length of road authorised by Article 2 to be used as a parking place;

[^0]"parking space" means a space which is marked out in a parking place for the leaving of a vehicle;
"postal packet" has the same meaning as in section 65(1) of the Postal Services Act 2011(a);
"specified hours" means the hours between 8.00 a.m. and 6.30 p.m. on the days Monday to Saturday inclusive; and
"universal service provider" has the same meaning as in section 65(1) of the Postal Services Act 2011.

## Authorisation of parking places

2. The use as parking places of the lengths of the roads specified in Schedule 1 is authorised.

## Position within a parking place

3. Save as provided in Article 5, a person shall not leave or cause a vehicle to be left in a parking place unless it is wholly within a parking space where such as has been marked out.

## Maximum period of waiting in and further use of a parking place

4.-(1) Subject to paragraph (2) and save as provided in Article 5 during the specified hours-
(a) a person shall not leave or cause a vehicle to be left in a parking place specified-
(i) in Part 1 of Schedule 1 for longer than 1 hour;
(ii) in Part 2 of Schedule 1 for longer than 30 minutes.
(b) a person shall not leave or cause that vehicle to be left again in that parking place until the expiration of 1 hour from the time that vehicle is removed from that parking place.
(2) The prohibitions in paragraph (1) shall not apply to a disabled person's vehicle.

## Exceptions

5.-(1) Nothing in Articles 3 or 4(1) shall render it unlawful to leave or cause a vehicle to be left in a parking place where the person in control of it is prevented from proceeding by circumstances beyond that person's control or to avoid an accident or for so long as may be reasonably necessary to enable-
(a) a person to board or alight from a vehicle left in a parking place before the expiration of 1 hour from the time that vehicle is removed from that parking place provided that such boarding or alighting does not cause that vehicle to be left again in that parking place for more than 2 minutes;
(b) the vehicle to be used in an emergency by a medical practitioner, or for fire and rescue, ambulance, police or customs purposes or for the purposes of the security forces;
(c) the vehicle to be used by or on behalf of a universal service provider for the purposes of the delivery to, or collection from, premises situated adjacent to the parking place of postal packets;
(d) the vehicle, if it cannot conveniently be used for such purposes outside that parking place, to be used-
(i) in connection with any building, repair or demolition operations;
(ii) in connection with the removal of any obstruction to traffic;
(iii) by or on behalf of a district council or a government department in pursuance of statutory powers or duties;

[^1](iv) by or on behalf of a sewerage undertaker or a water undertaker in connection with the discharge of that undertaker's functions;
(v) in connection with the discharge of the functions of the holder of a licence granted under Article 10 of the Electricity (Northern Ireland) Order 1992(a) or of a licence granted under Article 8 of the Gas (Northern Ireland) Order 1996(b);
(vi) in connection with the laying, erection, alteration or repair of any electronic communications apparatus as defined in Schedule 2 to the Telecommunications Act 1984(c); or
(e) goods to be loaded or unloaded from the vehicle.
(2) For the purposes of paragraph (1)(a) a vehicle shall be deemed to wait in the same place for more than 2 minutes if any one part of the carriageway is below any part of the vehicle or its load (if any) throughout the period exceeding 2 minutes whether or not the vehicle is moved during that period.

## Suspension of the use of a parking place

6. The Department may suspend the use of a parking place or any part of it for so long as may be necessary for the purpose of enabling-
(a) a vehicle, if it cannot conveniently be used for such purpose outside that parking place, to be used in connection with any of the following purposes-
(i) building, repair or demolition operations, including works to property adjacent to the parking place;
(ii) the removal of any obstruction to traffic;
(iii) the cleansing, maintenance, improvement or reconstruction of the road; or
(iv) the laying, erection, alteration or repair in, or in land adjacent to the road, of any sewer, main, pipe or apparatus for the supply of gas, water or electricity or of electronic communications apparatus as defined in Schedule 2 to the Telecommunications Act 1984;
(b) the implementation of any traffic management scheme; or
(c) street works as defined in Article 3(3) of the Street Works (Northern Ireland) Order 1995(d) to be executed.

## Prohibition of the use of a suspended parking place

7. A person not using a vehicle in connection with any of the undertakings specified in Article 6 shall not leave or cause that vehicle to be left in a parking place where the use of that parking place has been suspended by the Department in accordance with that Article.

## Removal of a vehicle in an emergency

8. A person authorised by the Department may remove a vehicle from a parking place in an emergency.

## Method of removal of a vehicle

9. Any person removing a vehicle by virtue of Article 8 may do so by towing or driving the vehicle, or in such a manner as is reasonably necessary and may take such measures as are reasonably necessary to enable that person to remove it.

## Custody of a vehicle

10. When a person authorised by the Department removes or makes arrangements for the removal of a vehicle from a parking place by virtue of Article 8 that person shall make such arrangements as may be necessary for the safe custody of the vehicle.

## Lengths of road on which vehicles must not wait

11. Save as provided in Article 12, a person shall not cause or permit a vehicle to wait-
(a) at any time on a length of road specified in Part 1 or Part 2 of Schedule 2; or
(b) during the specified hours on a length of road specified in Part 3 of Schedule 2.

## Exceptions to prohibition of waiting

12.-(1) Nothing in Article 11 shall render it unlawful to cause or permit a vehicle to wait on the carriageway of a length of road specified in Schedule 2 where the person in control of it is prevented from proceeding by circumstances beyond that person's control or to avoid an accident or for so long as may be reasonably necessary to enable-
(a) a person to board or alight from a vehicle provided that such boarding or alighting does not cause the vehicle to wait in the same place for more than 2 minutes;
(b) the vehicle to be used in an emergency by a medical practitioner, or for fire and rescue, ambulance, police or customs purposes or for the purposes of the security forces;
(c) the vehicle to be used by or on behalf of a universal service provider for the purposes of the delivery to, or collection from, premises situated adjacent to the length of road of postal packets;
(d) the vehicle, if it cannot conveniently be used for such purposes outside that length of road, to be used-
(i) in connection with any building, repair or demolition operations;
(ii) in connection with the removal of any obstruction to traffic;
(iii) by or on behalf of a district council or a government department in pursuance of statutory powers or duties;
(iv) by or on behalf of a sewerage undertaker or a water undertaker in connection with the discharge of that undertaker's functions;
(v) in connection with the discharge of the functions of the holder of a licence granted under Article 10 of the Electricity (Northern Ireland) Order 1992 or of a licence granted under Article 8 of the Gas (Northern Ireland) Order 1996; or
(vi) in connection with the laying, erection, alteration or repair of any electronic communications apparatus as defined in Schedule 2 to the Telecommunications Act 1984.
(2) Nothing in Article 11 shall render it unlawful to cause or permit a vehicle to wait on the carriageway of a length of road specified in Part 1 and Part 3 of Schedule 2 for so long as may be reasonably necessary to enable goods to be loaded or unloaded from the vehicle.
(3) For the purposes of paragraph (1)(a) a vehicle shall be deemed to wait in the same place for more than 2 minutes if any one part of the carriageway is below any part of the vehicle or its load (if any) throughout a period exceeding 2 minutes whether or not the vehicle is moved during that period.

## Revocations

13. The provisions specified in column (1) of Schedule 3 are revoked to the extent specified in column (3).

1. Asylum Road (south side in a lay-by) - from a point 12 metres west of its junction with Strand Road for a distance of 66 metres in a westerly direction.
2. Bishop Street Within (north-west side) - from a point 21.6 metres north-east of its junction with Society Street for a distance of 17.4 metres in a north-easterly direction.
3. Bishop Street Within (north-west side) - from a point 23 metres south-west of its junction with Society Street to a point 15 metres north-east of its junction with Palace Street.

8. Clooney Terrace (west side) - from a point 15 metres south of its junction with Melrose Terrace for a distance of 60 metres in a southerly direction.
9. Fahan Street (south-east side) - from a point 15 metres north-east of its junction with St. Columbs Wells for a distance of 154 metres in a north-easterly direction.
10. Fountain Street (south-east side) - from a point 15 metres south-west of its junction with Carlisle Road to a point 38 metres south-west of that junction.
11. Fountain Street (south-east side) - from a point 44 metres south-west of its junction with Carlisle Road to a point 15 metres north-east of its junction with Hawkin Street.
12. Glenshane Road (south-west side) - from a point 10 metres south-east of its junction with Belt Road for a distance of 18 metres in a south-easterly direction.
13. Glenshane Road (south-west side) - from a point 33.5 metres south-east of its junction with Belt Road for a distance of 40 metres in a south-easterly direction.
14. Horace Street (north-west side) - from a point 15 metres south-west of its junction with Carlisle Road for a distance of 5 metres in a south-westerly direction.
15. Horace Street (north-west side) - from a point 15 metres north-east of its junction with Hawkin Street for a distance of 17 metres in a north-easterly direction.
16. Little James Street (west side) - from a point 27 metres north of its junction with William Street for a distance of 65.4 metres in a northerly direction.
17. Queens Quay (north side) - from a point 9.5 metres east of its junction with Police Court Street for a distance of 28 metres in an easterly direction.
18. Queens Quay (west side) - from a point 14 metres north of its junction with Lower Clarendon Street for a distance of 40 metres in a northerly direction.
19. Queens Quay (west side) - from a point 74 metres north of its junction with Lower Clarendon Street for a distance of 25 metres in a northerly direction.
20. Queens Quay (west side) - from a point 108 metres north of its junction with Lower Clarendon Street for a distance of 12 metres in a northerly direction.
21. Shipquay Street (north-west side) - from a point 21 metres north of its junction with The Diamond for a distance of 36 metres in a north-easterly direction.
22. Shipquay Street (north-west side) - from a point 94 metres north of its junction with The Diamond for a distance of 42 metres in a north-easterly direction.
23. Strand Road (east side) - from a point 92 metres north of its junction with Lower Clarendon Street for a distance of 41 metres in a northerly direction.
24. Strand Road (east side) - from a point 137 metres north of its junction with Lower Clarendon Street for a distance of 30 metres in a northerly direction.
25. Strand Road (east side) - from a point 175 metres north of its junction with Lower Clarendon Street for a distance of 15 metres in a northerly direction.
26. Strand Road (north side) - from a point 15 metres east of its junction with Foyle Embankment for a distance of 30 metres in an easterly direction.
27. Strand Road (south side) - from a point 20 metres east of its junction with Foyle Embankment for a distance of 10 metres in an easterly direction.
28. Strand Road (west side) - from a point 11 metres north of its junction with Clarendon Street for a distance of 17 metres in a northerly direction.
29. Strand Road (west side) - from a point 47 metres north of its junction with Clarendon Street for a distance of 17 metres in a northerly direction.
30. The Diamond (south-east side) - from a point 12 metres south-west of its junction with Ferryquay Street for a distance of 2.5 metres in a south-westerly direction.
31. Whittaker Street (south-east side in a lay-by) - from a point 9.5 metres north-east of its junction with Foyle Street for a distance of 23 metres in a north-easterly direction.
32. William Street (north-east side in a lay-by) - from a point 8 metres south-east of its junction with Little James Street for a distance of 35 metres in a south-easterly direction.

Monday to Saturday 8.00 a.m. to 6.30 p.m. - Maximum stay 30 minutes; No return within 1 hour

4. Bishop Street Within (south-east side) - from a point 15 metres south-west of its junction with The Diamond to a point 15 metres north-east of its junction with London Street.
5. Bonds Hill (north-west side) - from a point 15 metres south-west of its junction with Termon Street for a distance of 182 metres in a south-westerly direction.
6. Bonds Hill (south-east side) - from a point 15 metres south-west of its junction with Clooney Terrace for a distance of 10 metres in a south-westerly direction.
7. Bonds Hill (south-east side) - from a point 47 metres south-west of its junction with Clooney Terrace for a distance of 20 metres in a south-westerly direction.
8. Bonds Hill (south-east side) - from a point 100 metres south-west of its junction with Clooney Terrace for a distance of 21.5 metres in a south-westerly direction.
9. Browning Drive (south side in a turning head) - from a point 233 metres west of its junction with St. Columbs Road for a distance of 35 metres in a southerly, then westerly and then northerly direction.
10. Deanfield (south-west side) - from a point 15 metres north-west of its junction with Limavady Road for a distance of 64 metres in a north-westerly direction.
11. Lone Moor Road (south-east side) - from a point 15 metres north-west of its junction with Foyle Road for a distance of 61 metres in a north-easterly direction.
12. Lone Moor Road (south-east side) - from a point 88 metres north-west of its junction with Foyle Road to a point 15 metres south-west of its junction with Brandywell Road.
13. Long Tower Court (both sides) - from a point 15 metres north-west of its junction with Bishop Street Without for a distance of 15 metres in a north-westerly direction.
14. Lower Bennett Street (south-west side) - from a point 15 metres south-east of its junction with Abercorn Road for a distance of 19 metres in a south-easterly direction.
15. St Columbs Road, Unclassified No. 1536 (south-west side) - from a point 15 metres north-west of its junction with Limavady Road for a distance of 224 metres in a northwesterly and then south-westerly direction.
16. St Columbs Road, Unclassified No. 1536 (south side) - from a point 254 metres west of its junction with Limavady Road for a distance of 67 metres in a south-westerly direction.
17. Termon Street (south side) - from a point 15 metres west of its junction with Bonds Hill for a distance of 13 metres in a westerly direction.

21. Kennedy Street (south-west side of the hammer head adjacent to No. 129 The Fountain) commencing at the western corner of the hammer head for a distance of 23 metres in a south-easterly and then south-westerly direction.

36. New Buildings Industrial Estate (south-west side) - from a point 150 metres south-east of its junction with Victoria Road for a distance of 30 metres in a south-easterly direction.
37. Newmarket Street (north-east side) - from its junction with Linenhall Street to a point 15 metres north-west of its junction with Orchard Street.
38. Newmarket Street (south-west side) - from its junction with Linenhall Street to a point 15 metres north-west of its junction with Market Street.
39. Orchard Street (north-west side) - from a point 15 metres north-east of its junction with Newmarket Street for a distance of 11 metres in a north-easterly direction.
40. Orchard Street (south-east side) - from opposite its junction with Newmarket Street for a distance of 32 metres in a north-easterly direction.
41. Railway Road (east side of the build-out adjacent to the entrance of Waterside House) from the junction of Waterside House for a distance of 8 metres in a north-westerly direction.
42. Railway Road (west side of the parking area) - from a point 3 metres from the front of Waterside House for a distance of 6 metres in a north-easterly direction.
43. Shipquay Street (north-west side) - from a point 15 metres north-east of its junction with The Diamond for a distance of 6 metres in a north-easterly direction.
44. St. Aidan's Terrace (south-west side) - from a point 15 metres south-east of its junction with Racecourse Road for a distance of 111 metres in a south-easterly direction.
45. Strand Road (east side) - from its junction with Sackville Street for a distance of 87.5 metres in a southerly direction.
46. Strand Road (west side) - from a point 15 metres south of its junction with Sackville Street for a distance of 1 metre in a southerly direction.
47. Waterloo Place (east side) - from its junction with Strand Road for a distance of 60 metres in a southerly direction.

## EXPLANATORY NOTE

(This note is not part of the Order)
This Order authorises lengths of Bishop Street Within, Londonderry, as specified in items 2 and 3 of Part 1 of Schedule 1 (Article 2), for the use as parking places and prescribes the conditions under which they may be used. Vehicles are excepted from the conditions in certain circumstances (Article 5). The Order also makes provision for the suspension of the use of the parking places (Article 6) and for the removal of a vehicle from the parking places in an emergency (Articles 8 and 9) and for its safe custody (Article 10).

This Order also prohibits vehicles from waiting on lengths of Bishop Street Within and Bonds Hill, Londonderry as specified in items 3, 4, 6, 7 and 8 of Part 1 of Schedule 2 and a length of Abbey Street, Londonderry as specified in item 1 of Part 2 of Schedule 2. Vehicles are excepted from the prohibitions in certain circumstances.

The Order also revokes the provisions specified in Schedule 3 and re-enacts the parking and waiting restrictions therein (Article 13).

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of this Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and the Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the items relating to Abbey Street, Bishop Street Within and Bonds Hill, Londonderry specified above will in due course be placed on the roads.
