**The Parking Places on Roads and Waiting Restrictions
(Dungannon) (Amendment) Order (Northern Ireland) 2023**

Made - - - - *5th December 2023*

Coming into operation *28th December 2023*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No objection has been received.

Citation and commencement

1. This Order may be cited as the Parking Places on Roads and Waiting Restrictions (Dungannon) (Amendment) Order (Northern Ireland) 2023 and shall come into operation on 28th December 2023.

Amendment

2.—(1) The Parking Places on Roads and Waiting Restrictions (Dungannon) Order (Northern Ireland) 2018^(d) is amended in accordance with paragraph (2).

(2) In Part 1 of Schedule 2 after item 61 add the following—

- “62. Granville Industrial Estate (north side) – from a point 288 metres north-west of its junction with Granville Road for a distance of 90 metres in a westerly direction.
- 63. Granville Industrial Estate (north and north-east side) – from a point 464 metres north, then west, then south and then west of its junction with Granville Road for a distance of 175 metres in a westerly and then northerly direction.
- 64. Granville Industrial Estate (south side) – from a point 279 metres north-west of its

- junction with Granville Road for a distance of 90 metres in a westerly direction.
65. Granville Industrial Estate (south side) – from a point 15 metres east of its junction with Eskragh Road for a distance of 90 metres in an easterly direction.
 66. Granville Industrial Estate (west side) – from a point 427 metres north, then west and then south of its junction with Granville Road for a distance of 30 metres in a southerly direction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places on Roads and Waiting Restrictions (Dungannon) Order (Northern Ireland) 2018 (“the Order”) by the addition to Part 1 of Schedule 2 of the items relating to Granville Industrial Estate as specified in Article 2.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the road.
