# The Parking and Waiting Restrictions (Londonderry) (Amendment) Order (Northern Ireland) 2023

Made - -

Coming into operation

13th December 2023 8th January 2024

The Department for Infrastructure(**a**) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No objection has been received.

#### Citation and commencement

**1.** This Order may be cited as the Parking and Waiting Restrictions (Londonderry) (Amendment) Order (Northern Ireland) 2023 and shall come into operation on 8th January 2024.

#### Amendments

**2.** The Parking and Waiting Restrictions (Londonderry) Order (Northern Ireland) 2023(**d**) shall be amended by the addition to Part 1 of Schedule 2 of the following items—

- "18. Duncreggan Road (north-west side) from a point 70 metres south-west of its junction with Aberfoyle Crescent South for a distance of 10 metres in a south-westerly direction.
- 19. Foxhill (south-east in turning bay) from a point 170 metres north-east and then south-west of its junction with Strabane Old Road for a distance of 33 metres in a south-easterly, then south-westerly and then north-westerly direction.
- 20. Richill Park (north-west side) (within a spur in front of Lisnagelvin Primary School) from a point 19 metres west of its north-eastern junction with Richill Park for a distance of 10 metres in a south-westerly direction."

### **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order amends The Parking and Waiting Restrictions (Londonderry) Order (Northern Ireland) 2023 ("the Order") by the addition of a no waiting at any time restriction (loading and unloading permitted) on the lengths of road specified in Article 2. Vehicles are excepted from the restriction in certain circumstances.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of this Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and the Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the roads.
