## ROAD TRAFFIC AND VEHICLES

The Parking Places (Disabled Persons' Vehicles) (Amendment No. 2) Order (Northern Ireland) 2023

*Made* - - - - 25th May 2023

Coming into operation - 19th June 2023

The Department for Infrastructure(**a**) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

One objection has been received and duly considered and no other representations have been received.

The Department has modified the draft Order.

### Citation and commencement

**1.** This Order may be cited as the Parking Places (Disabled Persons' Vehicles) (Amendment No. 2) Order (Northern Ireland) 2023 and shall come into operation on 19th June 2023.

3045.	Ligoniel Road, Belfast (south-west side) – from a point 15 metres north-west of its junction with Limehill Street for a distance of 8 metres in a north-westerly direction.
3046.	Oldpark Avenue, Belfast (south-west side in a lay-by) – from a point 70 metres south-west of its junction with Cliftonville Road for a distance of 5.5 metres in a south-westerly direction.
3047.	Rosebery Road, Belfast (east side) – from a point 15 metres north of its junction with Ardenvohr Street for a distance of 5.5 metres in a northerly direction.
3048.	Strandburn Drive, Belfast (north-west side) – from a point 37 metres south-west of its junction with Strandburn Parade for a distance of 5.5 metres in a south-westerly direction.
3049.	Sunnyside Drive, Belfast (north-west side) – from a point 74 metres south-west of its junction with Haywood Avenue for a distance of 5.5 metres in a south-westerly direction.
3050.	Ulsterville Avenue, Belfast (south-west side) – from a point 77.5 metres north-west of its junction with Ulsterville Drive for a distance of 5.5 metres in a north-westerly direction.
3051.	John F Kennedy Park, Bessbrook (north-east side in front of No. 54) – from a point 326 metres from its junction with Millvale Road for a distance of 6 metres in a south-easterly direction.
3052.	Green Road, Bessbrook (south-west side in front of No. 3 Fearons Terrace) – from a point 51 metres north-west of its junction with Newry Road for a distance of 6 metres in a north-westerly direction.
3053.	Tullywiggan Road, Cookstown (south-west side in front of No. 31 Tullywiggan Cottages) – from a point 118 metres south-east of its junction with Tullywiggan Cottages for a distance of 3 metres in a south-easterly direction.

3062.	Lisfannon Park, Londonderry (south-east side of a parking area) – from a point 66 metres north-east and then south-east and then north-east of its junction with Westland Street for a distance of 3.6 metres in a north-easterly direction.
3063.	Marlborough Road, Londonderry (north-west side) – from a point 47 metres south-west of its junction with Oakfield Drive for a distance of 4.5 metres in a south-westerly direction.
3064.	Rosemount Gardens, Londonderry (south-east side in a lay-by) – from a point 30 metre south-west of its junction with Rosemount Avenue for a distance of 6.6 metres in a south-westerly direction.
3065.	Annahugh Park, Loughgall (north side in front of No. 6) – from a point 30 metres north of its junction with Red Lion Road for a distance of 5 metres in a southerly direction.
3066.	Lisgullion Park, Newry (north-east side in front of No. 38) – from a point 152 metres south-east of its junction with Drumgullion Avenue for a distance of 6 metres in a south-easterly direction.
3067.	Violet Hill Avenue, Newry (north-east side in front of No. 12) – from a point 25 metres north-west of its southern junction with College Gardens for a distance of 6 metres in a north-western direction.
3068.	Downpatrick Street, Rathfriland (east side) – from a point 64 metres south of its junction with Main Street for a distance of 6 metres in a southerly direction."

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2016.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the roads specified in the Schedule and the removal of the parking places referred to in Article 2(2)(a).
