ROAD TRAFFIC AND VEHICLES

The Parking Places (Disabled Persons' Vehicles) (Amendment No. 4) Order (Northern Ireland) 2023

Made - - - - 25th May 2023

Coming into operation - 19th June 2023

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

One objection has been received and duly considered and no other representation has been received.

The Department has modified the draft Order.

Citation and commencement

1. This Order may be cited as the Parking Places (Disabled Persons' Vehicles) (Amendment No. 4) Order (Northern Ireland) 2023 and shall come into operation on 19th June 2023.

- **2.**—(1) The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2016(a) is amended in accordance with paragraphs (2) and (3).
 - (2) In Schedule 1—
 - (a) Delete the following—
 - (i) item no. 2868 relating to Grays Park, Belfast; and
 - (ii) item no. 1432 relating to Upper Violet Street, Londonderry.
 - (b) For item no. 1373 substitute the following—
 - "1373. Bishop Street Within, Londonderry (north-west side) from a point 15 metres south-west of its junction with Society Street for a distance of 7.8 metres in a south-westerly direction."
 - (c) Add the items set out in the Schedule to this Order; and
 - (3) In Schedule 4 substitute the following for item no. 2—
 - "2. Castle Street, Carrickfergus (north-west side) from a point 38.6 metres north-east of its junction with A2 Marine Highway for a distance of 7.6 metres in a north-easterly direction."

"3084.	Evelyn Avenue, Belfast (west side) – from a point 31 metres south-west of its junction with Upper Newtownards Roads for a distance of 6 metres in a south-westerly direction.
3085.	Sinclair Street, Belfast (south-east side) – from a point 28.5 metres north-east of its junction with Sandown Road for a distance of 5.5 metres in a north-easterly direction.
3086.	Walmer Street, Belfast (north-west side) – from a point 55 metres north-east of its junction with Haywood Avenue for a distance of 5.5 metres in a north-easterly direction.
3087.	Wellington Park, Belfast (south-west side) – from a point 74 metres north-west of its junction with Malone Road for a distance of 6 metres in a north-westerly direction.
3088.	Davys Street, Carrickfergus (south side in a parking area in front of No. 40) – from a point 124.6 metres north-west and then south-west of its junction with Irish Quarter South for a distance of 5.5 metres in a south-westerly direction.
3089.	Roseville Park, Lisburn (east side of cul-de-sac, in front No. 29) – from a point 60 metres north-east of its junction with Millbrook Road for a distance of 3 metres in a northerly direction.
3090.	Bishop Street Within, Londonderry (north-west side) - from a point 15 metres north-east of its junction with Society Street for a distance of 6.6 metres in a north-easterly direction.
3091.	Clon Elagh, Londonderry (south-east side in a parking area in front of No. 254) - from a point 78 metres south-east and then north-east of Clon Elaghs fifth off shoot on the eastern side of Clon Elagh from its eastern junction with Skeoge Link Road at a roundabout for a distance of 5 metres in a north-easterly direction.
3092.	Northland Avenue, Londonderry (north-east side) - from a point 32 metres northwest of its junction with Northland Terrace for a distance of 6 metres in a northwesterly direction.
3093.	Tutor Court, Londonderry (north-west side in a parking area) - from a point 18 metres north-east of its junction with Academy Road for a distance of 3.6 metres in a north easterly direction.
3094.	Tanners Court, Moira (north-west side to the side of No. 10) – from a point 60 metres south-east and then 12 metres south-west of its junction with Main Street for a distance of 6.6 metres in south- westerly direction.
3095.	Main Street, Scarva (east side) – from a point 18 metres north of its junction with Station Road for a distance of 6 metres in a northerly direction.
3096.	Ardallan Park, Warrenpoint (west side) - from a point 55 metres south-east of its junction with Burren Road for a distance of 3 metres in a south-easterly direction."

EXPLANATORY NOTE

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2016.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the roads specified in the Schedule and the removal of the parking places referred to in Article 2(2)(a) and the amendment of the items referred to in Articles 2(2)(b) and 2(3).
