**The Parking Places and Waiting Restrictions (Moy)
(Amendment No. 2) Order (Northern Ireland) 2024**

Made - - - - *15th May 2024*

Coming into operation *10th June 2024*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with Article 4(6) and paragraphs 1 and 2 of Schedule 1 to the Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as the Parking Places and Waiting Restrictions (Moy) (Amendment No. 2) Order (Northern Ireland) 2024 and shall come into operation on 10th June 2024.

Amendment

2.—(1) The Parking Places and Waiting Restrictions (Moy) Order 2016^(d) is amended in accordance with paragraph (2).

(2) In Part 1 of Schedule 2 after item 7 insert the following item—

“8. Jockey Lane (south-west side) – from a point 15 metres north-west of its junction with Benburb Road for a distance of 60 metres in a north-westerly direction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places and Waiting Restrictions (Moy) Order (Northern Ireland) 2016 (“the Order”) by the addition of a no waiting at any time restriction (loading and unloading permitted) on a length of Jockey Lane, Moy as specified in Article 2(2). Vehicles are excepted from the restriction in certain circumstances.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with The Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the road.
