The Kings Lane, Warrenpoint (Stopping-Up) Order (Northern Ireland) 2024

Made - - - - 19th June 2024

Coming into operation - 30th September 2024

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 68(1), (3) and (5) of the Roads (Northern Ireland) Order 1993(b) and now vested in it(c).

The Department in accordance with Article 68(4) of that Order is of the opinion that the lengths of road described in the Schedule are not necessary for road traffic.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

One hundred objections have been received and duly considered. Eight objections have been subsequently withdrawn.

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Kings Lane, Warrenpoint (Stopping-Up) Order (Northern Ireland) 2024 and shall come into operation on 30th September 2024.
- (2) In this Order "the contractor" means Killowen Contracts Limited whose registered office is situated at 35 Bridge Road, Burren, Warrenpoint, Newry, BT34 3QT.

Application

- **2.**—(1) The lengths of road described in the Schedule shall be stopped-up to vehicular traffic at the lines specified therein.
- (2) The contractor shall carry out such works as the Department considers necessary to prevent or restrict to such an extent as the Department thinks fit, access to the road described in the Schedule by vehicular traffic.
- **3.**—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the road to be stopped-up shall be retained.

(2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.

ROAD TO BE STOPPED-UP TO VEHICULAR TRAFFIC
