ROAD TRAFFIC AND VEHICLES

The Parking and Waiting Restrictions (Belfast) (Amendment No. 2) Order (Northern Ireland) 2024

Made - - - - 19th December 2024

Coming into operation - 10th January 2025

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) ("the 1997 Order") and now vested in it(c).

In accordance with paragraphs 1 and 2 of Schedule 4 to the 1997 Order, the Department has consulted such persons as it considers appropriate.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as the Parking and Waiting Restrictions (Belfast) (Amendment No. 2) Order (Northern Ireland) 2024 and shall come into operation on 10th January 2025.

Amendments

- **2.**—(1) The Parking and Waiting Restrictions (Belfast) Order (Northern Ireland) 2018(**d**) is amended in accordance with paragraphs (2) and (3).
 - (2) For Article 12 substitute the following—

"Lengths of road on which vehicles must not wait

- 12. Save as provided in Article 13, a person shall not cause or permit a vehicle to wait—
 - (a) at any time on a length of road specified in Part 1, Part 2 or Part 13 of Schedule 2;
 - (b) during the hours between 7.00 a.m. and 7.00 p.m. on the days Monday to Saturday inclusive on a length of road specified in Part 3, Part 4 or Part 14 of Schedule 2;

- (c) during the hours between 8.00 a.m. and 6.00 p.m. on the days Monday to Saturday inclusive on a length of road specified in Part 5 or Part 15 of Schedule 2;
- (d) during the hours between 8.00 a.m. and 6.00 p.m. on the days Monday to Friday inclusive on a length of road specified in Part 6 or Part 20 of Schedule 2;
- (e) during the hours between 9.30 a.m. and 4.30 p.m. on the days Monday to Friday inclusive on a length of road specified in Part 7 of Schedule 2;
- (f) during the hours between 8.30 a.m. and 9.30 a.m. and between 1.30 p.m. and 3.30 p.m. on the days Monday to Friday inclusive during the period from 31st August to 30th June on a length of road specified in Part 8 of Schedule 2;
- (g) during the hours between 10.00 a.m. and 3.00 p.m. on the days Monday to Saturday inclusive on a length of road specified in Part 9 of Schedule 2;
- (h) during the hours between 8.30 a.m. and 6.00 p.m. on the days Monday to Friday inclusive on a length of road specified in Part 10 of Schedule 2;
- (i) during the hours between 8.00 a.m. and 4.30 p.m. on the days Monday to Saturday inclusive on the length of road specified in Part 11 of Schedule 2;
- (j) during the hours between 8.00 a.m. and 6.30 p.m. on the days Monday to Friday inclusive on a length of road specified in Part 12 of Schedule 2;
- (k) during the hours between 8.00 a.m. and 6.30 p.m. on the days Monday to Saturday inclusive on the length of road specified in Part 16 of Schedule 2; or
- (l) during the hours between 8.00 a.m. and 6.30 p.m. on all days inclusive on a length of road specified in Part 17 or Part 18 of Schedule 2.
- (m) during the hours between 9.00 a.m. and 3.00 p.m. on the days Monday to Friday inclusive on a length of road specified in Part 19 and 21 of Schedule 2.
- (n) during the hours between 8.30 a.m. and 4.30 p.m. on the days Monday to Friday inclusive on a length of road specified in Part 20 and 22 of Schedule 2.
- (o) during the hours between 8.00 a.m. and 4.00 p.m. on the days Monday to Friday inclusive on a length of road specified in Part 23 of Schedule 2."
- (3) For Article 13(2) substitute the following—
 - "(2) Nothing in Article 12 shall render it unlawful to cause or permit a vehicle to wait on the carriageway of a length of road specified in Parts 1, 3, 5, 6, 7, 8, 9, 10, 11, 12, 17, 19, 20, 21, 22 or 23 of Schedule 2 for so long as may be reasonably necessary to enable goods to be unloaded or unloaded from the vehicle."
- (4) After Part 22 of Schedule 2 insert the following—

"PART 23

No Waiting Monday to Friday 8.00 a.m. to 4.00 p.m. – loading and unloading permitted

Carolan Road (south side) – from a point 46 metres west of its junction with Ormeau Road for a distance of 175 metres in a westerly direction."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking and Waiting Restrictions (Belfast) Order (Northern Ireland) 2018 ("the Order") by substituting new Articles 12 and 13(2) to include the new waiting restriction in Part 23 of Schedule 2 (Article 2(4)).

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the road.
