ROAD TRAFFIC AND VEHICLES

The Parking and Waiting Restrictions (Banbridge) (Amendment) Order (Northern Ireland) 2024

Made - - - - 20th March 2024

Coming into operation - 12th April 2024

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as the Parking and Waiting Restrictions (Banbridge) (Amendment) Order (Northern Ireland) 2024 and shall come into operation on 12th April 2024.

Amendments

- **2.**—(1) The Parking and Waiting Restrictions (Banbridge) Order (Northern Ireland) 2014(**d**) is amended in accordance with paragraphs (2) to (4).
- (2) In Article 1(2), for the definitions of "postal packet" and "universal service provider" substitute—

"postal packet" has the same meaning as in section 65(1) of the Postal Services Act 2011(e); and

"universal service provider" has the same meaning as in section 65(1) of the Postal Services Act 2011.

(3) For Article 11 substitute the following Article—

"Lengths of road on which vehicles must not wait

- 11. Save as provided in Article 12
 - (a) at any time on a length of road specified in Parts 1 or 2 of Schedule 2;
 - (b) during the hours between 8.30 a.m. and 6.15 p.m. on the days Monday to Saturday inclusive on the length of road specified in Part 3 or Part 5 of Schedule 2; or
 - (c) during the hours between 8.30 a.m. and 6.15 p.m. on the days Monday to Friday inclusive on the lengths of road specified in Part 4 of Schedule 2."
- (4) After Part 4 of Schedule 2 insert the following—

"PART 5

No Waiting Monday to Saturday – 8.30 a.m. to 6.15 p.m. – Loading and unloading permitted

Kenlis Court (west side) – from a point 50 metres north of its junction with Kenlis Street for a distance of 37 metres in a north-easterly direction."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking and Waiting Restrictions (Banbridge) Order (Northern Ireland) 2014 ("the Order") by amending the definitions of postal packet and universal service provider and substituting new Article 11 to include the new waiting restrictions in Part 5 of Schedule 2.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the road.
