**The Parking and Waiting Restrictions (Londonderry)
(Amendment) Order (Northern Ireland) 2024**

Made - - - - - *20th March 2024*

Coming into operation - *12th April 2024*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as the Parking and Waiting Restrictions (Londonderry) (Amendment) Order (Northern Ireland) 2024 and shall come into operation on 12th April 2024.

Amendment

2. The Parking and Waiting Restrictions (Londonderry) Order (Northern Ireland) 2023^(d) shall be amended by the addition to Part 1 of Schedule 2 of the following item—

“21. Spruce Meadows (north-east and east side of turning bay in front of No. 45) – from a point 243 metres north-west, then south, then west, then south-west of its junction with Ardanlee for a distance of 11 metres in an easterly then southerly direction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Parking and Waiting Restrictions (Londonderry) Order (Northern Ireland) 2023 by the addition of a no waiting at any time restriction (loading and unloading permitted) on a length of road at Spruce Meadows, Londonderry. Vehicles are excepted from the restrictions in certain circumstances.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of this Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and Penalty Charges (Prescribed Amount) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the road.
