**The Parking and Waiting Restrictions (Derry/Londonderry)
(Amendment) Order (Northern Ireland) 2025**

Made - - - - - *22nd January 2025*

Coming into operation *17th February 2025*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) (“the 1997 Order”) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with Article 4(6) of, and paragraphs 1 and 2 of Schedule 1 to, the 1997 Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as the Parking and Waiting Restrictions (Derry/Londonderry) (Amendment) Order (Northern Ireland) 2025 and shall come into operation on 17th February 2025.

Amendment

2.—(1) The Parking and Waiting Restrictions (Derry/Londonderry) Order (Northern Ireland) 2024^(d) is amended in accordance with Article 2(2).

(2) In Part 1 of Schedule 2 after item no. 21 add the following item—

“22. Nelson Drive (south-west side) – from a point 15 metres south-east of its junction with Broomhill Avenue for a distance of 36 metres in a south-easterly direction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Parking and Waiting Restrictions (Derry/Londonderry) Order (Northern Ireland) 2024 (“the Order”) by the addition of a no waiting at any time prohibition (loading and unloading permitted) on the length of road specified in Article 2(2).

Vehicles are excepted from the prohibition in certain circumstances.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with The Traffic Management (Northern Ireland) Order 2005 and the Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the road.
