# The U8017 (unnamed road) off Redrock Road, Markethill (Abandonment) Order (Northern Ireland) 2025

*Made - - - - 22nd January 2025* 

Coming into operation - 5th March 2025

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 68(1) and (5) of the Roads (Northern Ireland) Order 1993(b) and now vested in it(c).

The Department in accordance with Article 68(4) of that Order, being of the opinion that another road is available which provides alternative facilities for road traffic, proposes to abandon the area of road described in the Schedule as it is not necessary.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

#### Citation and commencement

**1.** This Order may be cited as the U8017 (unnamed road) off Redrock Road, Markethill (Abandonment) Order (Northern Ireland) 2025 and shall come into operation on 5th March 2025.

#### **Application**

- 2. The area of road described in the Schedule is abandoned.
- **3.**—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned area of road shall be retained.
- (2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.
