ROAD TRAFFIC

The A77 Trunk Road (Dalrymple Street, Girvan) (Temporary Prohibition of Traffic) Order 2012

Made - - - - *19th November 2012*

Coming into force - - *30th November 2012*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1), and (2), 4(1) and 16A of the Road Traffic Regulation Act 1984^(a) and of all other powers enabling them to do so.

In accordance with Section 16A(2) of that Act, they are satisfied that the traffic on the length of road specified in the Schedule should be prohibited for the purpose of facilitating the holding of a relevant event and enabling members of the public to watch that relevant event.

In accordance with Section 16A(3) of that Act, they are satisfied that it is not reasonably practicable for such an event to be held otherwise than on that length of road.

In accordance with Section 16A(8) of that Act, they have had regard to the safety and convenience of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A77 Trunk Road (Dalrymple Street, Girvan) (Temporary Prohibition of Traffic) Order 2012, comes into force on 30th November 2012 and ceases to have effect on 1st December 2012.

Prohibition on use of vehicles

2. No person shall use or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in the Schedule when such a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of traffic signs prescribed in diagram 7010.1 and 7105 of the Traffic Signs Regulations 2002^(b).

Exemptions

3. This Order does not apply to a vehicle while being used in an emergency for fire brigade, coastguard, ambulance, or police purposes, or a vehicle while being used in connection with the holding of the relevant event.

SCHEDULE

Article 2

That length of the southbound A77 Glasgow - Stranraer Trunk Road known as Dalrymple Street, Girvan from its junction with Knockcushan Street, Girvan to its junction with Wesley Road, Girvan, a distance of 355 metres or thereby.
