BUILDING AND BUILDINGS

The Building (Scotland) Act 2003 (Charging Orders) Regulations 2014

Made - - - - 16th December 2014

Laid before the Scottish Parliament 18th December 2014

Coming into force - - 7th February 2015

The Scottish Ministers make the following Regulations in exercise of the powers conferred by sections 33(1)(b)(ii) and 36(1) of the Building (Scotland) Act 2003(a) and all other powers enabling them to do so.

Citation, commencement and interpretation

- 1.—(1) These Regulations may be cited as the Building (Scotland) Act 2003 (Charging Orders) Regulations 2014 and come into force on 7th February 2015.
 - (2) In these Regulations "the Act" means the Building (Scotland) Act 2003.

Notification of making of a charging order

- **2.**—(1) Subject to paragraph (2), on making a charging order under section 46A of the Act(**b**), the local authority must—
 - (a) serve a copy of the charging order on the owner of the building concerned;
 - (b) advise the owner of the effect of the charging order; and
 - (c) notify the owner of—
 - (i) the right of appeal under section 47(3) of the Act against the charging order; and
 - (ii) the time limit within which such an appeal may be made.
- (2) Where a charging order relates to qualifying expenses (as defined in section 46B of the Act) that are recoverable under section 27(7)(b) of the Act from a relevant person (as defined in section 27(3) of the Act), other than the owner, the references in paragraph (1) to the owner of the building are to be read as references to the relevant person (as so defined) in relation to the building.

Form of charging order

3. A charging order is to be in the form set out in Schedule 1.

4. A discharge of a charging order is to be in the form set out in Schedule 2.

THE BUILDING (SCOTLAND) ACT 2003

CHARGING ORDER

We ¹ , in exercise of the power conferred by section 46A of the Building (Scotland) Act 2003, CHARGE the building described in the schedule with the repayable amount of ²
In the event of default of payment of an annual instalment, the instalment together with any amount recoverable in respect of that instalment under section 46C(2)(a) or (b) of the Building (Scotland) Act 2003 is separately recoverable as a debt.
If immediately after the final instalment falls due any balance of the repayable amour remains unpaid, that balance is immediately due for repayment and is recoverable as debt.
