## ROAD TRAFFIC

# The A86 Trunk Road (Newtonmore) (Temporary Prohibition on Waiting, Loading and Unloading) Order 2018

Made - - - - 17th October 2018

Coming into force - - 24th October 2018

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that traffic on the length of road specified in the schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

#### Citation, commencement and cessation

**1.** This Order may be cited as the A86 Trunk Road (Newtonmore) (Temporary Prohibition on Waiting, Loading and Unloading) Order 2018, comes into force on 24 October 2018 and ceases to have effect on 26 October 2018.

#### Prohibition on waiting, loading and unloading

**2.** No person may use, or permit the use of, any vehicle to wait, load or unload on the length of road, or a part or parts of the length of road, specified in the schedule when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of one or both of the traffic signs of the types described in item 19 (diagrams 636 – temporary prohibition of waiting except for loading and unloading) and item 20 (diagram 636.1 – temporary prohibition of loading and unloading) of the sign table in Part 6 of schedule 13 of the Traffic Signs Regulations and General Directions 2016(**b**).

## **Exemptions**

- **3.** No prohibition imposed by this Order applies to—
  - (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or
  - (b) a vehicle being used for carrying out the works.

# **SCHEDULE**

Article 2

# SPECIFIED LENGTH OF ROAD

That length of the A86 Spean Bridge – Kingussie Trunk Road in Laggan Road, Newtonmore from its junction with Loch na Leoba Road, Newtonmore in a north easterly direction to a point 30 metres or thereby south west of the junction with Craigdhu Road, a distance of 210 metres or thereby.
