The M8/A8 Trunk Road (Bay Street, Port Glasgow) (Prohibition of Specified Turns) Order 2019

Coming into	force	-	-	2nd August 2019

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 1(1)(a) and 2(1) and (2) of the Road Traffic Regulation Act 1984(**a**) and all other powers enabling them to do so.

In accordance with section 1(1)(a) of that Act, they consider it expedient to make this Order for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.

The Scottish Ministers have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(b).

Citation and commencement

1. This Order may be cited as the M8/A8 Trunk Road (Bay Street, Port Glasgow) (Prohibition of Specified Turns) Order 2019 and comes into force on 2 August 2019.

Prohibition of specified turns

2. No person may use, or permit the use of, any vehicle on the length of road specified in Part 1 of the schedule of this Order so as to make any turn specified in Part 2 of the schedule.

SCHEDULE

Article 2

PART 1

SPECIFIED LENGTH OF ROAD

That length of the M8/A8 Edinburgh - Greenock Trunk Road from a point 270 metres or thereby west of Newark Roundabout, Port Glasgow to a point 300 metres or thereby west of Newark Roundabout, Port Glasgow, a distance of 30 metres or thereby.

PART 2

SPECIFIED TURNS

1. All right turns from the eastbound M8/A8 Edinburgh – Greenock Trunk Road to Bay Street, Port Glasgow.

2. All right turns from Bay Street, Port Glasgow to the eastbound M8/A8 Edinburgh – Greenock Trunk Road.
