ROAD TRAFFIC

The A84 Trunk Road (Blair Drummond) (Temporary Prohibition on Use of Road and Temporary 30mph Speed Restriction) Order 2023

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 16A of the Road Traffic Regulation Act $1984(\mathbf{a})$ and all other powers enabling them to do so.

In accordance with section 16A(2) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted or prohibited for the purpose of facilitating the holding of a relevant event and enabling members of the public to watch that relevant event.

In accordance with section 16A(3) of that Act, they are satisfied that it is not reasonably practicable for the event to be held otherwise than on a road.

In accordance with section 16A(8) of that Act, they have had regard to the safety and convenience of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A84 Trunk Road (Blair Drummond) (Temporary Prohibition on Use of Road and Temporary 30mph Speed Restriction) Order 2023, comes into force on 8 August 2023 and ceases to have effect on 12 August 2023.

Prohibition on use of road

2. No person may use or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in Part 1 of the schedule when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 8 (diagram 7105 - position of barrier to mark length of road closed or to guide

Speed restriction

3. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of a length of road, specified in Part 2 of the schedule at a speed exceeding 30 miles per hour when a restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 1 (diagram 670 - maximum speed limit in mph) of the sign table in Part 2 of schedule 10 of the Traffic Signs Regulations and General Directions 2016.

Exemptions

4. No prohibition imposed by this Order applies to—

- (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes, or
- (b) a vehicle being used for facilitating the holding of the relevant event.

5. No speed restriction imposed by this Order applies to-

- (a) vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(b) when used in accordance with regulation 3(5) of those Regulations, or
- (b) vehicles being used in an emergency for coastguard purposes.

SCHEDULE

Articles 2 and 3

SPECIFIED LENGTHS OF ROAD

PART 1

That length of the A84/A85 Stirling – Crianlarich Trunk Road from its junction with B8075 Kirk Lane, in a northerly direction to its junction with A873, a distance of 316.89 metres or thereby.

PART 2

That length of the A84/A85 Stirling – Crianlarich Trunk Road from a point 174 metres or thereby north of its junction with U220157 Cuthill Brae, in a southerly direction to its junction with U020480 Sommers Lane, a distance of 1.8 kilometres or thereby.
